Mr. Bell also stated that Mr. Jim Drawdy had brought action against Dorchester County, and at this time Mr. Bell advises that Dorchester County should continue with the action.

3. Mr. Edmond Knight moved to accept Mr. Jim Bell's recommendations concerning Mr. Richard Sweat. Seconded by Mr. George Knight. All in favor. The motion carried.
4. Mr. Handelsman moved to freeze the remaining appropriated funds for the BDED until we can verify compliance with this assistance program. There was no second. The motion failed.

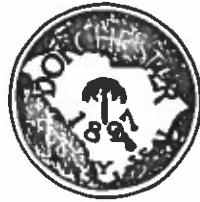
