If Mobile Home is moving <u>out</u> of Dorchester County – you only need to obtain a Moving Permit from the Assessor's Office

BEFORE A MOBILE HOME CAN BE PLACED ON PROPERTY

A VALID ADDRESS IS REQUIRED ***** NO SHARING OF ADDRESSES

STEP 1

Zoning Approval Letter:

Complete the Zoning Approval letter for new site location from the Planning & Zoning Dept in Summerville @ 500 N Main St.

- ✓ Location Address with tax parcel # of property.
- ✓ Site plan of lot showing Mobile Home placement & setbacks from Mobile Home to property lines.
- ✓ Property Ownership OR Lease Agreement.

Note:

- ✓ Property with existing septic tank & well you will need to check with Water & Sewer department for availability/need to tap into line vs. existing septic tank (DCWAS, 235 Deming Way, 843-832-0075).
- ✓ New property with new septic at time of Set up Application we will need final construction approval from DHEC Dept (843-953-0465).
- ✓ Property with existing sewer & water receipts showing account set up in name.
- ✓ New property with sewer & water at time of Set Up Application we will need the paid sewer & water receipts from the appropriate offices DCWAS 843-832-0075, Summerville CPW 843-871-0810, Water Authority 843-875-0140.
- ✓ New Property in District II -
 - ❖ District II school impact fee will apply (\$2500.00) unless a waiver letter from the school is obtained, 843-873-2901 ext 3022.
 - ❖ Transportation fee will also apply (\$581.00). To be paid at time of Set-Up application.

(Both fees will not apply if there was an occupied home previously on the property).

✓ District IV – Transportation Fee of \$581.00 may apply depending upon address.

STEP 2

Obtain your Decal / Moving Permit from the Assessor's Office.

Your Decal / Moving Permit within county will be issued @ assessor's office after the Zoning Letter is approved. You will need the following:

- ✓ Buying from a dealer form 400 & buyer's contract along with moving permit from other county.
- ✓ Buying from individual to new owner clear title in new owners name or form 400 completed with moving permit from other county.

STEP 3

Mobile Home Set Up Application

Mobile Home Set-Up Permit is obtained at the Building Dept in Summerville @ 500 N Main St.

- ✓ New owner will need to provide decal information from assessors.
- ✓ Same owner will need to provide moving permit from assessors.
- ✓ If moving from another county into Dorchester County you will need to provide proof of Wind Zone II. You will also need to provide a copy of the moving permit from the County it is being moved from.
- ✓ If moving within Dorchester County no wind zone data needed
- ✓ If property is in a flood zone you will need to provide a flood elevation certificate (obtained from a surveyor) at time of application and again at time of inspection.
- ✓ If not existing septic you will need to provide the DHEC final septic construction approval letter after installation OR sewer & water paid receipts from the appropriate office.
