1. On the motion of Councilman Davis, seconded by Councilwoman Duncan, Council voted unanimously to adopt the minutes from the April 4, 2016, County Council Meeting.

PRESENTATION OF RESOLUTION #16-03, CELEBRATING THE LIFE OF MRS. ESSIE JOHNSON

Chairman Chinnis invited family and friends of Mrs. Essie Johnson to come forward as he read the resolution, which was previously adopted by Council at the March 21, 2016, meeting. Councilman Davis then presented the framed resolution to the family.

Mrs. Sullivan presented the March 2016 budget report and answered questions.

COUNTY ADMINISTRATOR'S TIME - MR. JASON WARD

REZONING REQUEST #720

2. On the motion of Councilman Davis, seconded by Councilwoman Duncan, Council voted unanimously to give 3rd Reading and final approval of Rezoning Request #720 for Locklair Consulting to rezone 118.55 acres at SC Hwy 27 in Ridgeville from Absence of Control (AC) to Industrial (I) and General Commercial (CG), TMS #087-00-00-050.

FIRE RECOVERY FUNDS

3. On the motion of Councilwoman Duncan, seconded by Councilman Hearn, Council voted unanimously to recognize fire recovery funds in the amount of \$10,200 and authorize the expenditure of these funds to purchase uniforms and equipment and to make repairs to Dorchester County Fire Rescue Station 8 in Ridgeville.

CARRYOVER FIRE FUNDS

4. On the motion of Councilman Davis, seconded by Councilwoman Duncan, Council voted unanimously to recognize FY16 Carryover Fire Funds and authorize the expenditure of \$21,211 for 800 MHz radio flash upgrades and equipment for Brush Truck 3.

AUTOMATIC AID AGREEMENT

5. On the motion of Councilman Davis, seconded by Councilman Hargett, Council voted unanimously to approve an Interlocal Agreement for Automatic Aid between Dorchester County Fire Rescue and Summerville Fire Department and authorize the County Administrator to execute the agreement. Mr. Ward said this agreement was approved on April 13 by the Town Council of Summerville.

During discussion, Councilman Hargett asked for confirmation that no monies will be passed either way in the event of aid. The Chairman and Administrator confirmed. Councilwoman Duncan asked why it is a one-year contract, although renewable. Mr. Potts said the contract is evergreen.

Chairman Chinnis addressed what he described as a war of fear waged by the board of the Old Fort Fire Department. He said the first casualty has been the truth. They are entitled to their own opinions; they are not entitled to their own facts, he said. Tax District 209 will have the same or better service. He displayed maps showing coverage areas and noted improvements that will occur.

Chairman Chinnis thanked the men and women of the Dorchester County Fire Rescue for creating a department from many disparate parts that residents can be proud to call their own.

There were additional comments of support from Council members.
