(The purpose of this amendment is to reduce conflicts between competing form-based code requirements in the East Edisto Master Plan and further, to provide a mechanism for relief from such conflicts subject to administrative approval.)

WHEREAS, Dorchester County Council has adopted Ordinance No. 12-20 approving a development agreement by and between Dorchester County (SC) and

MWV – East Edisto Dorchester, LLC (the Parties);

WHEREAS, Ordinance No. 12-20 vested the East Edisto Form District Master Plan, Ordinance No. 12-19, for a period of 50 years to guide the growth and development of some 38,000 acres in southwestern Dorchester County known as East Edisto:

WHEREAS, the Parties to the development agreement wish to amend certain regulations within Schedule II of the East Edisto Form District Master Plan to improve their effectiveness;.

NOW, THEREFORE, be it ordained by Dorchester County Council, duly assembled, that the East Edisto Form District Form District Master Plan, Ordinance Number 12-19, is amended as attached.

Except as specifically amended hereby, the East Edisto Form District Form District Master Plan, Ordinance Number 12-19, as amended hereby shall remain in full force and effect.
