TRANSFER OF OWNERSHIP OF A SURPLUS 2009 TRANSPORT VAN

TRANSFER OF PERSONNEL SAVINGS – UPGRADE TO CAMA SYSTEM

15. On the motion of Councilman Davis, seconded by Councilman Chinnis, Council voted six in favor, with one absent (Byars), to approve a one-time transfer of personnel savings of \$23,000 to fund a critical upgrade to the Computer Assisted Mass Appraisal (CAMA) System that will allow automated changes to residential assessment ratio changes and right-of-way/plat recording.

PART-TIME TEMPORARY PART-TIME BILLING ASSISTANT

COMMITTEE REPORTS

CHAIRMAN CHELLIS – PUBLIC WORKS, PROPERTY AND UTILITIES COMMITTEE

Chairman Chellis reported that the Committee met on January 26, 2017 at 5:00 p.m., and voted unanimously to recommend 3rd Reading of an Ordinance, Amending and Supplementing the Code of Ordinances, Dorchester County, South Carolina, by Deleting Section 36-180, Chapter 36, Article VI and Substituting in Lieu Thereof a New Section 36-180, Chapter 36, Article VI (Stormwater Fee).

17. Council voted four in favor, with two opposed (Hargett and Bailey), with one absent (Byars), to approve the Committee's recommendation.

<u>CHAIRMAN DAVIS – ADMINISTRATIVE AND INTERGOVERNMENTAL AFFAIRS</u> <u>COMMITTEE</u>
