Chairman Byars wished Councilman Davis a quick recovery and asked that he be kept in everyone's thoughts and prayers.

REQUESTS TO ADDRESS COUNCIL

- Ms. Anna Pinckney, 2392 West Aviation Avenue, North Charleston, presented a \$250,000 check to Dorchester County on behalf of SCANA for the Ridgeville Commerce Park.
- Ms. Cherylee Bowerbank, 161 Country Lane, Dorchester, requested County Council ride down Wire Road prior to sending the sandpit issue back to the Board of Zoning Appeals.
- Mr. Kyle Ruddock, 1526 Zion Road, Dorchester, stated he has concerns about another hole in the ground that cannot be used for anything once mining is completed.
- Mrs. Shannon Ruddock, 1526 Zion Road, Dorchester, presented County Council with a statement of facts regarding the impacts of a sandpit in her community.
- Mr. Terry Gerling, 162 Country Lane, Dorchester, stated he is a new resident in the area and requested County Council make the party requesting the permit bear the burden of proof that the sandpit will have no negative impact on the community.
