Chairman Feltner called the meeting to order and Councilman Hargett gave the Invocation.

REQUEST TO ADDRESS COUNCIL

Chairman Feltner asked if there were any requests to address Council and the following citizens replied:

 Mr. John Braund, Chairman of the Dorchester County Taxpayer's Association, addressed Council and requested that Council adopt the proposed Resolution that was formally named Resolution #09-24, regarding impact fees. He stated that the Dorchester County Taxpayer's Association urged Council to support the Resolution. Page Two

REQUEST TO ADDRESS COUNCIL CONTINUED

- Mr. Phillip Ford, Executive Vice President of the Charleston Trident Homebuilders Association, addressed Council, and requested they not reconsider the proposed Resolution #09-24; regarding transportation impact fees. He further requested the Resolution be delayed as stated at the December 7th, 2009, Council Meeting.
- Mrs. Sue Wehman addressed Council, and stated that the Transportation Master Plan was completed and the next step in the process was as mandated by the Comprehensive Plan, as adopted by County Council. She stated that the next step in the process would be the adoption of the proposed Resolution #09-24, concerning a transportation impact fee plan for the Planning Commission to review and make recommendations, and that she supported this action by requesting that Council support this study by adopting the Resolution.
- Mr. Ryan Castle addressed Council in opposition to the proposed Resolution #09-24, with language that directs the County's Planning Commission to conduct studies on an impact fee ordinance, but stated that he favored an amended Resolution supporting a Capital Improvements Plan for Transportation.
- Mr. Mac Baughman, representing MeadWestvaco addressed Council regarding the
 proposed Resolution #09-24, and voiced their support of this Resolution. He stated
 that they supported funding mechanisms that are consistent with state law and
 offered their support during the review process directing the Dorchester County
 Planning Commission to conduct the studies on an impact fee ordinance for
 transportation improvements plans.
- Mr. Tom Roe, Executive Director of the SC Landowners Association, addressed Council in opposition to proposed Resolution #09-24. Mr. Roe stated that he felt impact fees were not in the best interest to constituents to assess a tax that would be a disincentive to residential and commercial growth and the creation of jobs. In addition, Mr. Roe said that the Landowners Associations was not against "Transportation Improvements", but against impact fees.
- Mr. Elliott Morris addressed Council regarding "An Ordinance Restricting the
 Hours of Operation of Commercial Establishments Which Allow for the OnPremises Consumption of Alcohol Beverages", and he requested that Council look
 at this on behalf of the "gentlemen's agreement", he and other bar owners made
 with Council about closing at 3:00 a.m.
- Mr. Mike Murphree, a former member of Dorchester County Council, addressed Council in opposition to proposed Resolution #09-24, regarding "The Republic". He stated that impact fees would raise taxes as it has done in other counties.
- Mr. John Mojonnier addressed Council and presented them with an update on the "Dorchester Road Widening Project", from Ashborough and Ashborough East Subdivisions. He also gave Council a handout regarding this subject.
- Mr. George Barber addressed Council, and requested the reconsideration of the proposed Resolution #09-24, and for the same to be passed on to the Planning Commission for their recommendations, and stated that a transportation plan was necessary.

WHEREAS, Dorchester County Council has previously appointed a Transportation Citizens Advisory Committee, as well as engaged the services of Kimley-Horn and Associates to undertake an analysis of future transportation needs in Dorchester County; and

WHEREAS, Dorchester County desires to implement impact fees within the unincorporated areas of the County for the primary purpose of funding capital improvements which increase or increased the service capacity of public facilities relating to roads, streets and bridges, including, but not limited to, rights-of-way and traffic signals as such term public facilities is defined in Section 6-1-920(18)(d), Code of Laws of South Carolina (1976), as amended; and

WHEREAS, in order to implement such fees, Dorchester County is required to enact a resolution directing the Dorchester County Planning Commission to conduct the studies and to recommend an impact fee ordinance developed in accordance with the South Carolina Development Impact Fee Act as more fully set forth in Section 6-1-950, Code of Laws of South Carolina (1976), as amended.

NOW, THEREFORE, BE IT RESOLVED by Dorchester County Council, duly assembled, that the Dorchester County Planning Commission is hereby directed to conduct studies and to recommend an impact fee ordinance for a capital improvements plan for public facilities, such public facilities being limited to roads, streets and bridges, including, but not limited to, rights-of-way and traffic signals, as the term public facilities is more specifically defined in Section 6-1-920(18)(d), Code of Laws of South Carolina (1976), as amended.

GUESTS MS. CHARLOTTE ALLEN, CPA, WEBSTER ROGERS, LLP

Ms. Charlotte Allen, CPA, Webster Rogers, LLP, thanked Council for allowing her firm to perform the audit this year and all administrative offices in Dorchester County. Ms. Allen made a presentation to Council of the Fiscal Year 2009 Audit and pointed out items of interest. She stated that the County received a clean audit and received and answered questions from Council.

MR. JOHN DUMAS, PRESENTATION OF FRAMED COUNTY SEAL

Mr. John Dumas, who designed the County's new seal, presented Council with a matted and framed copy of the New County Seal.

- 12. On the motion of Mr. Hargett, seconded by Mr. Davis, Council voted unanimously to have another copy of the new County Seal matted and framed, and to have them displayed in each of the Dorchester County Council Chambers, in St. George and Summerville.
- 13. Mr. Murphy amended the motion, seconded by Mr. Hearn, and Council voted unanimously, to have the second copy framed and matted exactly as the County Seal presented, and to use funds from the County Council contingency account to pay for the expenses incurred.

MS. VONIE GILREATH, MOBILITY MANAGER FOR THE BERKELEY-CHARLESTON-DORCHESTER COUNCIL OF GOVERNMENTS

Ms. Vonie Gilreath, Mobility Manager for the Berkeley-Charleston-Dorchester Council of Governments presented the Trident Rideshare Program and the Berkeley-Dorchester Hazard Mitigation Plan, 2010 Update, to County Council. She stated that the entire proposed Hazard Mitigation Plan, 2010, Update was on Dorchester County's website and the executive summary was sent to Council, and that this plan needed to be adopted at Council's next meeting. Ms. Gilreath stated that before adoption of the Hazard Mitigation Plan, 2010, Update, that public meetings were required, and Berkeley County held its meeting in December of 2009, and this was the Public Meeting for Dorchester County.

In addition, Ms. Gilreath presented the Trident Rideshare Program. She included in her presentation the many benefits of the Rideshare Program, including the reduction of travel expense, reduction in stress, improvement in air quality, benefit from flexibility, and the improvement of networking. Council thanked Ms. Gilreath for her presentation.

MRS. ASHLEY MCDONALD, DEPUTY COUNTY ADMINISTRATOR

RECOMMENDATION ON RECOVERY AUDITS

Mrs. Ashley McDonald, Deputy County Administrator, made a presentation to Council on Recovery Audits and the potential benefits of this type of audit. The fee for this type of audit is usually a percentage of the amount discovered. After the presentation and discussion by Council, the following motion was made.

14. On the motion of Mr. Hargett, seconded by Mr. Davis, Council voted unanimously to approve that the County send out a Request for Proposal to hire a firm to perform a Recovery Audit for up to the last five fiscal years.

ELECTRONIC MONITORING DEVICES FOR NON-VIOLENT OFFENDERS

In addition, Mrs. McDonald discussed using <u>electronic monitoring devices for non-violent offenders</u>. She stated that some Counties were using these devices to help with overcrowding in their jails. Council Members also added to the discussion of the rules of allowing an offender the use of electronic monitoring devices. This subject was discussed for information only at this time. In addition, it was discussed that a meeting should take place later between the proper officials, including the Sheriff, Family Court Judges, and other individuals to be decided later, as stated by the County Administrator.

Additionally, it was discussed that County Council needed to express concern to the Members of the South Carolina Sentencing Reform Commission and the Dorchester County Legislative Delegation regarding the potential process change that would require counties to house prisoners that are sentenced to 180-365 days in county jails (local detention facilities). According to Sheriff Knight, this change would increase the Dorchester County jail's daily population by 40-60 inmates.

15. On the motion of Mr. Murphy, seconded by Mr. Rosebrock, Council voted unanimously to send a letter to the Members of the South Carolina Sentencing Reform Commission or the Dorchester County Legislative Delegation, expressing opposition to "Sentencing Reform", regarding the holding of prisoners sentenced to 180-365 days in county jails, to express the effect of overcrowding on the Dorchester County Detention Center.

MR. WILL ABBERGER, DIRECTOR OF CONSERVATION FINANCE, THE TRUST FOR PUBLIC LAND, CONSERVATION FINANCE PROGRAM RECOMMENDATIONS

Mr. Will Abberger, Director of Conservation Finance for The Trust for Public Land, made a presentation to Council on the "Conservation Finance Program Recommendations". Mr. Abberger presented the key findings from the telephone survey conducted by the Trust for Public Land.

Mr. Abberger stated that in March of 2009, he presented the Dorchester County, Conservation Finance Feasibility Study to Council. The Feasibility Study reviewed funding options available for financing land conservation and open space acquisition in Dorchester County. It determined the fiscal capacity and legal requirements of various approaches and provided relevant demographic information, and election history. Mr. Abberger reported that the funding approach that best matches the needs identified by the County was a General Obligation Bond.

GUESTS, MR. WILL ABBERGER - CONTINUED CONSERVATION FINANCE PROGRAM RECOMMENDATIONS

By State Law, general obligation debt in Dorchester County cannot exceed 8% of the total assessed valuation of taxable property. Therefore, in order to go above this constitutional debt limit, the electorate of the County must approve an increase through a Referendum. In September of 2010, The Trust for Public Land commissioned a public opinion survey of Dorchester County voters. Mr. Abberger reported that currently, a strong majority of Dorchester County voters would support a \$5 million bond to protect and improve land to improve water quality (including drinking water), natural areas, protecting wildlife habitat, historic preservation, and providing green space and parks for recreation. He stated that the Trust also found when provided with additional information, the support for the \$5 million bond increased.

In conclusion, Mr. Abberger stated that the recommendation of the Public Land Trust was that the "Council direct the County Administrator and County Attorney to work with the Trust for Public Land to develop the appropriate Resolution and ballot language for consideration by Council to refer a \$5 million General Obligation Bond to fund land conservation (for the items listed above) to the November 2, 2010 ballot." After discussions by Council members, Council thanked Mr. Abberger and the Trust for Public Land for all of their hard work on this issue. Upon no objections from Council, the Chairman referred this item to the Budget, Finance, and Purchasing Committee for further study along with the upcoming FY 2010-2011 Budget.

MR. JOHN H. LEWELLEN, PRESIDENT/ TRI-COUNTY ATHLETICS "THE ORIGINAL" SCHOOL OF HARD KNOX- SUMMERVILLE BOXING TEAM-REQUEST FOR FUNDING

Mr. John H. Lewellen, President and Head Coach of Tri-County Athletics, thanked Council for the previous funding that they provided to the School and made a new "Request for Funding" to Council. The request was in the amount of \$4,300 for training and equipment (head gear, training gloves, groin protection, and competition uniforms). Coach Lewellen addressed Council, gave an overview of his organization, and introduced a few of students. He stated that the mission of this nonprofit organization was to help each young person that walks through the door, regardless of their ability to pay, which helped the community as a whole, and strived to teach them self-esteem, self-discipline, morals, values, and sportsmanship. Ms. Robinson said that she wished every County could have a Councilman as active as Councilman Rosebrock, and that he was an inspiration to all citizens for the work he does with the Keep Dorchester County Beautiful Program, and the Adopt a Highway Program. Councilman Rosebrock said he was humbled and honored by this special award, and intended to continue his work by "*Keeping Dorchester County Beautiful*". In addition, Councilman Rosebrock's family attended the presentation.

Mr. Garon Jackson, Executive Director, Lower Orangeburg Upper Dorchester CDC, addressed Council and requested funding in the amount of \$27,000. The funding request was to provide training to the residents of Upper Dorchester County. Mr. Lee Moulder, Director of Budget and Finance, presented Council with the January 2010 Budget Report. He stated that the County now has received the majority of the tax revenues and the fees for the solid waste and the stormwater funds, and he was encouraged that with the collections that the County was close to the average amount collected versus the budget in prior years. After Mr. Moulder gave the Budget Report, he and the Administrator addressed concerns and answered questions from Council. MOTION TO AMEND THE AGENDA

REQUEST TO ADDRESS COUNCIL

Chairman Feltner asked if there were any requests to address Council, and the following citizens replied:

- Mrs. Angie Lee Crum addressed Council regarding a request for sewer in a rural area of Ridgeville. She requested that Dorchester County assist this area in getting sewer service for the citizens who live there, when and if the County becomes aware of any available grant funding for rural sewer projects. The Chairman requested Mrs. Crum to provide the County Administrator with the exact location of the area in Ridgeville.
- Mrs. Jean Bunch addressed Council regarding Rezoning Request #630, for Ms. Dana L.
 Eiser, and requested that this request be denied and not be rezoned. She also presented
 Council with a petition supporting this request.
- Mr. Frank Thomas addressed Council on behalf of the Upper Dorchester County Historical Society and invited Council to visit significant sites in the upper part of Dorchester County on March 20, 2010. An invitation/letter was given to each Council Member and the Administrator. (note: The Clerk was not provided with a copy.)
- Mr. John Hammontree addressed Council regarding the road he lives on, Dogwood Ridge Road. He informed Council of the ongoing situation regarding this road, the standards required for county maintenance and requested the County take over the maintenance of Dogwood Ridge Road. (By request of Councilman Waggoner and no objections from Council, Mr. Hammontree was given extra time to speak). Chairman Feltner placed this item/request in the Public Works, Property, and Utilities Committee.
- Mr. Jim Bryan with SCANA Corporation addressed Council regarding the proposed Resolution regarding the South Carolina Electric and Gas 9.5% rate increase in retail electric base rates, and said the company has done everything it can to cut costs. He explained the reasons his company finds it necessary to request an increase in their rates and explained how they plan to implement the increase over time. Mr. Bryan thanked Council for allowing him to address them on this issue.

Councilman Hargett made remarks with regard to the proposed Resolution and stated his views on why now was not the time for SCE&G to request a rate increase from the Public Service Commission. He stated that he had received many calls from taxpayers who had extremely high electric bills and felt they could not afford to pay any higher cost. Councilman Hargett stated that SCE&G was a good partner with Dorchester County and its economic development activities and Dorchester County does appreciate the partnership participation, however now was not the time in our economy, for a rate increase for our citizens. After his remarks, Councilman Hargett read aloud his proposed Resolution as follows:

"WHEREAS, the Dorchester County Council requests that the Public Service Commission (PSC) of South Carolina deny the current request from South Carolina Electric and Gas (SCE&G) seeking a 9.5% rate increase in retail electric base rates. An increase in electric base rates during this current recessionary period with families, businesses, churches, and governmental agencies struggling to survive would cause hardship and jeopardize the viability of many in our county. Some small businesses whose electric bills are a significant part of their operating cost factor are fighting to keep their heads above water. Notwithstanding the increase in rates that SCE&G is requesting, this Council has received reports from some concerned citizens who are now paying \$500 to \$900 per month for residential electric bills from SCE&G, which is more than an average family's monthly food cost. The Dorchester County School District 2 paid over \$4,000,000 in electric bills last year to SCE&G and would realize a \$380,000 increase in electricity bills for School District 2 should the requested rate increase receive approval by the Public Service Commission (PSC). Dorchester County Government paid \$1,260,000 last year for electricity from SCE&G for operation of county government operations with an expected increase of \$119,700 for next year's electricity billing. South Carolina law entitles SCE&G to a reasonable return on their investment to produce and distribute electricity to its customers; however, the timing of this requested rate increase is not prudent due to the present economic recession.

WHEREAS, electric utility base rates are set, and monitored by the Public Service Commission (PSC) in South Carolina, the Dorchester County Council respectfully requests that the PSC deny any increase in retail electric base rates by SCE&G. With summertime coming in a few months, many homes and businesses will experience even higher electric bills than in past months should the requested increase rate by SCE&G be granted by the PSC.

NOW, THEREFORE, BE IT RESOLVED, that upon adoption of this Resolution, the original shall be presented to the Public Service Commission, with a copy to the members of the Dorchester County Legislative Delegation and a copy shall be filed in the permanent records of Dorchester County, South Carolina." After reading the proposed Resolution, the following motion was made.

After Council held discussions, Councilman Murphy stated that it was the Public Service Commission's job to determine if a rate increase was warranted or not and it should be left to them to decide. Councilman Murphy proposed having a letter drafted to the Public Service Commission, expressing the same sentiments as the proposed Resolution, and this way each Council Member who chooses to sign the letter could. He made the following amendment to Councilman Hargett's motion:

Mr. Murphy motioned to amend the main motion, seconded by Mr. Hearn, Council voted five in favor, and two opposed, to have a letter drafted to the Public Service Commission instead of a Resolution, expressing the same sentiments as the proposed Resolution, with each Council Member having the option of signing it.

Council Members Waggoner and Hargett opposed.

At the end of the discussions, Chairman Feltner thanked SCE&G for helping the County when the winter weather hit Dorchester County in February, and many residents lost power. He stated that they worked around the clock to restore power to their customers. Each Member of Council took time to thank South Carolina Electric and Gas for being an excellent economic development partner with Dorchester County.

<u>PETITION FROM RESIDENTS OF RENAU BOULEVARD, HUNTERS CREEK AND PINE FOREST COUNTY CLUB</u>

Councilman Hearn reported he had received a call over the past weekend concerning a petition from residents of Renau Boulevard, Hunters Creek and Pine Forest County Club.
