ARTS BUSINESS CIVIC COALITION-FUNDING REVISION

Chairman Hargett recognized Mr. Ward, County Administrator, and requested that he provide an overview on the above referenced titled subject.

Mr. Ward reported that Council had previously awarded funding to the Arts Business Civic Coalition for the purpose of having funding to match a grant, which did not occur as planned. The Town of Summerville and the Arts Business Civic Coalition were able to secure other funding in lieu of the grant funds; and, therefore it would have sufficient funds to hire the Strategic Advisory Group for a Civic Center Feasibility Study for the Summerville area, which would include the previously committed funds by Dorchester County.

<u>PUBLIC HEARING ON PROPOSED COUNTY REDISTRICTING PLANS RESULTING</u> FROM REAPPOINTMENT (PURSUANT TO SEC. 4-9-90, SC CODE ANN.)

Chairman Hargett stated that a Public Hearing would be held on the proposed County Redistricting Plans and stated that the purpose of redistricting was to bring balance to the representation of citizens to County Council members and to come into compliance with the 1965 Voting Rights Act, as amended. He stated the process would be performed under the direction of the United States Department of Justice (DOJ). After the decennial Census, the County Council district lines would be redrawn to allow for the change of population throughout the County. Each district would be drawn in a way that allows for them to provide balanced representation based upon population.

Chairman Hargett reported the purpose of this meeting was to review the redistricting plan that the Budget and Control Board Office of Research and Statistics proposed and to review the redistricting plans, which have been produced by the County and reviewed by the Budget and Control Board Office of Research and Statistics, and to receive public comments on those plans. He further stated that the plans had been made available for public review on the County's web site and in both County Libraries.

The basic guidelines for Redistricting are as follows:

- o Adherence to the Constitutional Requirement of One Person, One vote (i.e., mathematically equal districts)
- o County Councils must adhere to State Law of Population Variance under 10%
- o Adherence to the 1965 Voting Rights Act as amended
- o Ensure that Parts of Districts are Contiguous
- Respect Communities of Interest
- o Attempt to Maintain Constituent Consistency
- o Avoid Splitting Voting Precincts
- o Solicit Public Input

PUBLIC HEARING ON PROPOSED COUNTY REDISTRICTING PLANS RESULTING FROM REAPPOINTMENT (PURSUANT TO SEC. 4-9-90, SC CODE ANN.)-CONTINUED

Chairman Hargett opened the Public Hearing to receive comments and recognized Mr. Bobby Bowers with the South Carolina Budget and Control Board Office of Research and Statistics to present two plans that most conform to the redistricting guidelines.

Mr. Bowers thanked Council for adopting the 7 Criteria (reference Motion #1). He stated that although State Law recommends going under 10% of the population variance, he would recommend going way under the 10%, due to possible legalities and stated that if someone presented a plan with a lesser variance than the County's plan, then a Federal Court would take the plan with the least variance.

Mr. Bowers explained the process of how their recommendation was decided. He stated that by viewing the current bench mark plan, which was the plan the Dorchester County currently operates under from 2000 and with the 2010 data. Mr. Bowers reported reviewing the information Council had a deviation of 62.13%, which was determined by taking the largest positive and the largest negative without regard to the algebraic sign and then adding them together. Mr. Bowers reported Council District 7 was the largest positive in the County, which showed 8,040 people too high or 41.21%. The County's largest negative was Council District 1, which showed 4,082 people too low or 20.92%. Mr. Bowers explained that by combining the two percentages you come up with 62.13% deviation. He stated the goal with the criteria were to draw the deviation as close as possible without too much extreme, to adhere to the 1965 Voting Rights Act, which was formed to prevent diminishing the minorities opportunities to select a candidate of their choice. Mr. Bowers further explained the challenges for the plans being presented, and concluded that the County had done everything within its power to prevent retrogression and to construct a district that would offer minorities an opportunity to select candidates of its choice. Mr. Bowers stated they had gone out of the way to ensure they had met the Voting Rights Criteria. Mr. Bowers further stated he recommended Plan 7, due to it having the lowest deviation of 2.05% and had a 54.52% of minority population with 54.69% of Non-Hispanic/Black voting age population, which would be slightly below the current bench mark of 55.8%.

A question and answer session was held between Mr. Bowers and members of Council, and no actions were taken.

Chairman Hargett recognized Mr. David Garber, GIS Coordinator, for the purpose of him presenting Council with an overview of the major changes for each plan being proposed by the County, which excluded Plan 4.

A question and answer session was held between Mr. Garber and members of Council and no actions were taken.

Chairman Hargett opened the Public Hearing to receive public input and the following comments were received:

- Mr. Jack Jackson, resident of Dorchester County, came before Council, Mr. Jackson stated he had sent a FOIA Request to the County requesting all information regarding this topic, including Plan 4 and as of this date he stated he had not received any information. Mr. Jackson also expressed concerns of the topic of Redistricting being discussed in Executive Session and not being discussed in open session.

Chairman Hargett introduced Mr. Heath McCutcheon with Carsonite Composites and reported that Mr. McCutcheon would be presenting Council with an overview of its product relating to the subject of Noise/Sound Barriers (the product Acousta Shield).

ONE CENT SALES TAX AUTHOIRTY ROAD CONSTRUCTION CONTRACTS AND STATUS

Mr. McCutcheon, representative of Carsonite Composites located in Newberry, South Carolina, came before Council and demonstrated the type of materials used in their product of sound/noise barriers. He presented a video presentation of various completed project sites from around the country and an overview of Carsonite Composites installation process, the company's history, and explained that the product was manufactured in the State of South Carolina.

Concluding Mr. McCutcheon's presentation, further discussions were held on the issue of Carsonite Composites not being approved by the South Carolina Department of Transportation (SCDOT). During discussions between Council members, members of the Sales Tax Transportation Authority (Authority), Davis and Floyd Engineering, Inc., and Mr. McCutcheon, it was explained that the Dorchester Road project had already been bided out to a contractor and prior to the bidding process being completed Public Hearings were held approximately 2-3 years ago, which was the time frame of when the public's input and comments were received. Mr. Dukes reported that at the time of when public meetings were being held, Ashborough subdivision was very active in the process, and during those meetings, residents were provided with several types of construction materials for consideration in constructing sound barriers for the Dorchester Road project. Mr. Dukes explained that it was the majority of participants who selected the sound barriers material (concrete), which consequently was the same material specified by the State. In addition, this is the time frame when the color selection was made by the residents, as well.

Discussions were held on the subject of Carsonite Composites not currently being a recognized as a vendor by the State of South Carolina. Chairman Hargett stated he would review this issue with one of the County's State Senators. Vice Chairman Bailey stated he would contact members within the SC DOT to discuss this matter with them. Vice Chairman Bailey agreed that Dorchester Road was a State road with State right-of-ways, and the construction of the road was required to meet State standards.

Members of Council offered their assistance to the Sales Tax Transportation Authority on future projects, and stated that if the Authority were faced with an opportunity to save money, but needed a political solution; Council would be willing to take the necessary measures needed.

Members of the Authority and Mr. Dukes provided status updates on the following projects, as requested by the County Administrator, Mr. Ward, and no actions were taken:

- Warning signs of change in speed limit, but not having the 45 mph speed limit signs located on Hwy 78 going into Dorchester and into St. George
- Hwy 78 Phase II and III funding sources and environmental permitting, right-of-way status
- Intersection of Deming Way/Orangeburg/ Hwy 27
