REZONING REQUEST #760

4. On the motion of Councilman Hearn, seconded by Councilman Bailey, County Council voted five in favor, with one opposed (Chinnis), and one absent (Davis), to give 1st Reading and referral to the Planning, Development, and Building Committee for a Public Hearing and recommendation regarding Rezoning Request #760 by Hopper Communities to rezone 4.37 acres located on Orangeburg Road in Summerville from General Commercial District (CG) to Single-Family Attached Residential District (R-3), TMS #136-00-00-202.

ROAD MAINTENANCE APPLICATION, SUMMERS CORNER PHASE 1B

5. On the motion of Councilman Bailey, seconded by Councilman Hearn, County Council voted six in favor, with one absent (Davis), to approve a road maintenance acceptance application for Summers Corner Phase 1B.

APPROVAL OF FUNDS FOR SOUTH CAROLINA TECHNICAL COLLEGE SYSTEM REGIONAL TRAINING CENTER

- 6. On the motion of Councilman Bailey, seconded by Councilman Hearn, County Council voted six in favor, with one absent (Davis), to approve the use of \$750,000 in Capital Funds toward the \$5.5 Million purchase of 1090 Newton Way, Summerville, also known as the American LaFrance Building, to be used by the South Carolina Technical College System as a Regional Training Center with the following conditions for approval/release of funds:
 - 1. Contingent upon Berkeley and Charleston counties approving funding;
 - 2. Contingent upon a minimum of 15,000 square feet being set aside for Trident Tech classes;
 - 3. Contingent upon a deed restriction requiring SC Technical College System to transfer ownership of the building if they stop using it for training for 180 consecutive days.

TRANSFER OF CONTRACTUAL OPERATING FUNDS FOR PERSONEEL IN THE DELINQUENT TAX OFFICE AND A NEW PART-TIME POSITION IN THE CORONER'S OFFICE

7. On the motion of Councilman Chinnis, seconded by Councilman Hearn, County Council voted six in favor, with one absent (Davis), to approve a transfer from contractual operating funds to regular wages in the Delinquent Tax Office to upgrade a Posting Clerk to an Admin IV-Posting Clerk (Grade 8), and a new 20-hour part-time Deputy Coroner (Grade 11) position in the Coroner's Office. This will allow the county to comply with the findings of the 2015 IRS Audit.

APPROVAL OF LETTER TO SCDOT REGARDING TWO RAILROAD CROSSINGS ON HIGHWAY 78

Mr. Ward announced that additional information was received and requested that County Council take no action regarding approval of a letter to SCDOT that expresses Dorchester County's concern about a proposal to install two at grade railroad crossings that would affect mobility along a hurricane evacuation route (Highway 78) and near one of our newest and largest industrial parks near Highway 27. No action was taken.
