### ADOPTION OF RESOLUTION #18-24, IN MEMORY OF COUNCILMAN WILLIE R. DAVIS

2. On the motion of Councilman Bailey, seconded by Councilman Hargett, County Council voted five in favor, with one absent (Chinnis), to adopt Resolution #18-24, In Memory of Councilman Willie R. Davis.

Councilman Bailey said Councilman Davis was one of the first people he met when he came to Dorchester County. Councilman Bailey said he had no idea they would be serving on Council together. He said Councilman Davis' chair will never be filled. Councilman Bailey said he would like to purchase the chair and give it to the family.

Councilman Hargett said Councilman Davis was his friend also. He said he was the kind of man you could go to and ask a question or tell him something you were bothered about. Councilman Hargett said he and his wife had the privilege of going to St. Mark United Methodist Church Friday evening for the wake. He said they received a blessing because they met people like his current pastor, former pastor and his former, former pastor. Councilman Hargett said some of the things they had to say about Councilman Davis confirmed what they already knew. He was a wonderful man of God. He said it was a blessing to spend time with people he didn't know but through Councilman Davis' death and funeral he met some wonderful people at St. Mark United Methodist Church.

Councilman Chellis said as the new guy on Council it is not uncommon for him to put his foot in his mouth or make a dumb remark. He said Councilman Davis would every now and then nudge him and set him straight. Councilman Chellis said he brought up a question to Mr. Frampton during the meeting to which afterwards he was politely told by several Councilmen how dumb it was. He said he was a wonderful person, he was colleague, he was a friend to all. He said it is fair to say that everyone who knew him, loved him and he will be missed severely. Councilman Hearn said it is not the same. He said his smile, laugh and his encouraging words will be missed. His passing teaches us all that you never know how much time you have left. He said we are praying for the Davis family, love them and will ask the Lord to continue to bless them.

Mr. Ward said the toughest thing for him was when Councilman Davis passed out at the Economic Development Retreat. He said it was tough because he saw his father pass away and he was wondering on that day if it was going to repeat. Mr. Ward said he took his daughter and mother with him to visit Councilman Davis at Trident. He said they took the Bible and shared scripture with him. Mr. Ward said Councilman Davis told him he was like a son to him. He said when you lose your father at a young age you are looking for those role models you can seek advice from and pattern yourself after. Mr. Ward said he looked up to Councilman Davis as someone
