REQUESTS TO ADDRESS COUNCIL

2ND READING OF AN ORDINANCE TO REPEAL AND REPLACE THE DORCHESTER COUNTY PROCUREMENT ORDINANCE

2. On the motion of Councilman Chellis, seconded by Councilman Hargett, County Council voted unanimously to give 2nd Reading of an Ordinance to Amend the Code of Ordinances, Dorchester County, South Carolina, to Repeal Chapter 2, Article VI, Divisions 1 Through 10 and Substitute In Lieu Thereof New Divisions 1 Through 10 (The purpose of this ordinance is to repeal and replace the Dorchester County Procurement Ordinance, first adopted in 1983 and last revised in 2015. These changes reflect a modernization of the ordinance, alignment with the State Procurement Ordinance, and adhere to best practices in public procurement.)

ADOPTION OF RESOLUTION #18-26, APPOINTING GEORGE BAILEY AS COMMISSIONER OF THE LAKE MARION REGIONAL WATER AGENCY

3. On the motion of Councilman Chellis, seconded by Councilman Hearn, County Council voted unanimously to adopt Resolution #18-26, a Resolution Appointing George Bailey to Represent Dorchester County as a Commissioner of the Lake Marion Regional Water Agency and Jason Ward to Serve as an Alternate Representative.

ADOPTION OF RESOLUTION #18-27, RECOGNIZING MR. ED BURNS FOR HIS YEARS OF SERVICE TO DORCHESTER COUNTY

4. On the motion of Councilman Hearn, seconded by Councilman Chellis, County Council voted unanimously to adopt Resolution #18-27, a Resolution Recognizing Mr. Ed Burns for His Years of Dedicated Service to Dorchester County.

COUNCIL MEMBER'S TIME – MR. GEORGE BAILEY

Councilman Bailey thanked county employees for their hard work during Hurricane Florence. He said he wanted to thank them from the bottom of his heart for what they do for the people of Dorchester County.

Councilman Hearn said he had the experience on Thursday morning of going to one of the County's Convenience Sites and staff there was incredibly helpful, friendly, and had a very positive attitude on a day when they were called back in to work. He said they did their jobs well and he thanks them for what they were able to do in those five hours that made a big difference.

Councilman Hargett thanked Sheriff Knight for the increased presence of deputies in neighborhoods. He said it was a comfort during the storm and he appreciated it very much.

On the motion of Councilman Bailey, seconded by Councilman Chellis, County Council voted unanimously to give 3rd Reading of Ordinance #18-17, an Ordinance to Amend Dorchester County Zoning and Land Development Standards Ordinance Number 04-13, as Previously Amended, to Repeal Article XIV "Administration, Enforcement, Appeals, Complaints and Remedies", Article XV "Board of Zoning Appeals", and Article XVI "Amendments" and Replace with New Article XIV, "Administration, Enforcement, & Amendments", New Article XV "Board of Zoning Appeals", and New Article XVI "Planning Commission"; and to Revise Sections 7.4.4, 7.5.5, 7.7.5, 7.8.5, 7.9.5, 7.12.5, 8.2.4, 8.3.4, 9.1.3.2, 9.2.4, 11.1.6(a), 11.1.6.(e), 11.1.7, 11.1.8, 11.1.9, 11.2.11, and 11.6.6, to Update Code Section References (The purpose of this amendment is to eliminate errors and inconsistencies, update public notice requirements, create standard processes, and allow for easier finding of information for the Board of Zoning Appeals and Planning Commission.)
