Chairman Byars called the meeting of Dorchester County Council to order. He invited all to stand for the invocation and the Pledge of Allegiance by Councilman Hearn.

CHAIRMAN'S TIME

REQUESTS TO ADDRESS COUNCIL

Ms. Erica Wright, Charleston Metro Chamber of Commerce, 4500 Leeds Avenue, N. Charleston, she
discussed growth and housing affordability. Not only is there growth from people relocating to the area but

from within as well. Based on population projections 7,500 new housing units annually will be needed. Most of the homes will need to be priced for households earning less than \$50,000 annually. The Chamber would like to partner with the County moving forward to see what they can do to address housing attainability for everyone.

- Ms. Jennifer Schuchart, Capital Bank, 4500 Leeds Avenue, N. Charleston, she spoke about attainable housing from the standpoint of an employer. She said that attainability of housing continues to impact the growth of businesses that are already here, that want to locate here or that want to expand here. The housing costs are vastly outpacing wage growth and there is a fundamental supply and demand problem. She said from an employer perspective, employees who can't afford to live where they work seek opportunities outside the region. As an employer she asked County Council to expedite and review the permitting process for affordable workforce housing to bring more supply into the market, and review zoning regulations to ensure appropriate density and usage. The Chamber would like County Council to partner with them and work together on solutions to address the crisis.
- Ms. Tiffany Dorris, 2153 Hummingbird Lane, Summerville, she said she represents a group of teachers in Dorchester District 2 that are advocates for themselves and their students. She said a primary obstacle is class sizes and asked how County Council plans to deal with overcrowding issues in Dorchester District 2 schools. As a group of teachers, they would like input from County Council on what they can do to help in that endeavor.
- Mr. Christopher K. Mizzell, 3490 Wire Road, St. George, he said for the past few months he has been trying to obtain permits to build a home. He spoke with multiple builders who turned him down because he lived in Dorchester County. He was told he needed a wetland survey by Dorchester County staff before permits could be issued because there appears to be wetlands on the property. This survey will cost him over \$1,000 on a piece of property where there is currently a mobile home and working well. He asked County Council why every home builder in Dorchester County is not required to have a wetlands survey.
- Ms. Linda Haynes Whetsell, 108 Atlantic Street, Summerville, she spoke about dust, granite particles and exhaust fumes. She said it is harmful to your breathing, cars and buildings. There is trash and flooding in the area where she lives and said something must happen.
