CHAIRMAN'S TIME

REQUESTS TO ADDRESS COUNCIL

Mr. Audrine Washington, 108 Mill Pond Road, Dorchester, he said the road he lives on is in terrible condition.
 He asked Council to reconsider and fix his road. He said he was told the road is private property and can't be maintained by the County.

- Mr. Nick Russo, 5435 Altamaha Drive, North Charleston, he said he just found out his department is closing on July 1st. He said they are a Class 1 ISO Fire Department. He would like for Council to ask the Chief about putting another ambulance in the department rather than closing the department.
- Mr. Marques Bush, 5117 Morrow Lane, North Charleston, he spoke about several incidents with North Charleston and said he is concerned with the lack of response. He asked several questions about the dissolution of Ashley River Fire Department and what would happen to his homeowner's insurance.
- Mr. Scott Inabinet, 651 Gahagan Road, Summerville, he spoke about the Ashley River Fire Department and presented data about their response times. He asked why no notice was given to the district about the dissolution of the Ashley River Special Tax District. He requested the item be deferred.
- Dr. Richard Duncan, 5533 Jasons Cove, North Charleston, he said he is disillusioned with the methodology
 of the process. He said he is angry with the process and has questions about the future of the fire department
 and its staff. He requested the item be delayed and the question be put on a ballot for the taxpayers to decide.
