REQUESTS TO ADDRESS COUNCIL

- Mr. Thomas Feagin, 111 Ponderosa Drive, Summerville, he spoke about the upcoming election. He requested Council look at traffic on Orangeburg, Butternut and Mallard Roads. He said the quality of life is diminishing by the day because of traffic.
- Ms. Peggy Bangle, 114 Ravenwood Court, Summerville, Councilwoman Holman and her family are in her thoughts and prayers. She spoke about voting and encouraged everyone to go out and vote. "If you don't vote, you can't whine." She also spoke about traffic, taxes and trash. She said we need traffic studies to make our roads more efficient.

2. On the motion of Councilman Hargett, seconded by Councilman Hearn, County Council voted six in favor, with one absent (Holman), to adopt Resolution #19-18, a Resolution Recognizing and Celebrating the Veterans of Dorchester County and its Surrounding Counties on the Occurrence of the 2019 Dorchester County Veterans Parade and Celebration.

EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM

Chairman Bailey announced that Dorchester County is eligible for a grant of \$28,779. The funds will be used to equip the Sheriff's Office with eight (8) night vision monocular and helmet mount assemblies for use by the Special Entry Team.

The public hearing is a requirement of the grant, and no vote of County Council is required.

Chairman Bailey struck the gavel, opening the public hearing. In the absence of any requests to speak, Chairman Bailey struck the gavel again, closing the public hearing.

Further, with respect to this settlement as well as the previously approved settlements with the other Defendants, the County Administrator and Chief Financial Officer be authorized apportion the net proceeds from such settlements between Dorchester County and the Town of Summerville based upon the total revenues received from each Defendant by Dorchester County for fiscal year 2018 commencing July 1, 2017 through and including June 30, 2018, and the total revenues received from each Defendant by the Town of Summerville for calendar year 2018.
