Chairman Hearn called to order the meeting of the Dorchester County Council. He invited all to stand for the invocation, which was given by Councilman Davis and followed by the Pledge of Allegiance.

#### CHAIRMAN'S TIME – MR. WILLIAM R. HEARN, JR.

Chairman Hearn welcomed back Ms. Leslie Cantu of the Summerville Journal Scene. He also noted that Mr. Ward, County Administrator, had guests in the audience. Mr. Ward introduced his wife, Alana; two daughters, Jayla and Janae; and his mother, Viola. Mr. Ward also announced the passing of Mr. Mike Goldston's mother-in-law, Gloria Thrower Dangerfield. Mr. Goldston is the Dorchester County Interim Public Works Director.

REQUESTS TO ADDRESS COUNCIL:

- Ms. Bev Watson, 209 W. 7<sup>th</sup> N. Street, Summerville, asked Council to provide a generator for Dorchester Seniors, Inc., in Summerville for use during storms when the facility becomes a shelter. Mr. Ward said the senior center is designated as a special medical needs shelter. He said the County will deliver a generator topped off with fuel for use during the next emergency.
- Ms. Lisa Machajewski, 517 Twin Lakes Drive, Ridgeville, asked Council to pave Stable Lane. She said she purchased property in February on Stable Lane and has since learned the property has major drainage problems. She requested assistance with options for fixing drainage issues in order to build a house on the property.
- Ms. Peggy Bangle, 114 Ravenwood Court, Summerville, asked Council to allow Habitat for Humanity to deconstruct the Thurman home in Trotters Ridge, which is being purchase by the County for removal.
- Ms. Debbie Ainscough, 189 McMakin Street, Summerville, asked Council for an update regarding any plans to improve drainage in Pine Hill Acres. Mr. Ward said the required engineering work has been completed. He said monies have been authorized in the current fiscal year to purchase easements and improve drainage. The current fiscal year began July 1, 2014, and ends June 30, 2015.

Ms. Neuner is the mother of a son with autism and elopement behaviors that cause him to wander from caregivers. Ms. Horres is a case manager for children and adults with disabilities. They presented to Council information about Project Lifesaver, a program that distributes GPS transmitter bands attached to the wrist or ankle of clients with autism, dementia and other disabilities. When a client is reported missing to law enforcement officials, the transmitter is activated, reducing the amount of time and number of deputies needed to locate a wanderer. Ms. Neuner and Ms. Horres asked Council to allocate \$5,000 to fund start-up costs to implement the program in Dorchester County in cooperation with the Sheriff's Department and local nonprofit organizations. The Chairman referred this item to the Public Safety, Health and Human Services Committee.

Chairman Hearn called to order the meeting of the Dorchester County Council. He invited all to stand for the invocation, which was given by Councilman Hargett and followed by the Pledge of Allegiance.

Chairman Hearn recognized from the audience Senator Sean Bennett and Mr. David Ginn, President and CEO of the Charleston Regional Development Alliance. He thanked them for attending the meeting.

#### CHAIRMAN'S TIME - MR. WILLIAM R. HEARN, JR.

REQUESTS TO ADDRESS COUNCIL: No one addressed Council.

#### ADOPTION OF MINUTES

1. On the motion of Councilman Davis, seconded by Councilman Chinnis, Council voted six in favor, with one abstention, to adopt the minutes from the July 21, 2014, County Council meeting. Councilman Byars abstained.

#### ADOPTION OF PROCLAMATION #14-05

2. On the motion of Councilman Bailey, seconded by Councilman Byars, Council voted unanimously to adopt Proclamation #14-05, designating August 17-23, 2014, as Aviation Week in Dorchester County.

Chairman Hearn read the proclamation and presented it to Mr. Don Hay, Dorchester County Aviation Director. Mr. Ward recognized the service of Mr. Carl Walters, Jr., a longtime member of the Dorchester County Aeronautics Board, who passed away July 31. He noted that this occurred while Council and staff were out of town attending the South Carolina Association of Counties annual meeting. Councilman Davis and Councilman Bailey offered anecdotes about Mr. Walters and praised his civic service.

CORRESPONDENCE: Items were sent to Council as they were received by staff.

#### GUESTS - MR. DAN DENNIS AND MR. MATT HINES OF DENNIS CORP.

Mr. Dennis updated Council on the SC Highway 165 road improvement project, saying it is in good shape regarding both schedule and budget. He said right-of-way acquisition on the 2.5-mile project began in June. He reviewed the project timeline, which includes permitting approval from the South Carolina Department of Transportation (SCDOT) anticipated in mid-October, followed by advertising for construction and awarding of a construction contract in November. He reported that there are weekly coordination meetings with utility companies to ensure all issues are resolved before construction begins in December. The project completion date is slated for December 31, 2015.

Mr. Dennis answered questions from Council members and introduced Mr. Hines, Project Manager. There was some discussion about pre-qualifying bidders, requiring liquidated damages, offering incentives for 12-month project completion and requesting a limited warranty. Regarding the composition of the new road, Mr. Dennis said the pavement will be reclaimed, mixed with the sub-base and cement to create a new sub-base without using stone in order for the project to proceed quickly. On top of the sub-base, he said there will be three layers of asphalt. Project engineers will keep traffic moving on the two existing lanes and build a majority of the project in the new alignment, then shift traffic to restructure the two old lanes, said Mr. Dennis.

There was some discussion about working with the State Infrastructure Bank (SIB) to receive approval for linking the multi-use path at the Ashley River Bridge with the designed eight-foot-wide, multi-use path that would parallel the 2.5-mile length of the Highway 165 road project. Because the Highway 165 project is under budget and because the public wants the additional path, Mr. Dennis said the SIB would likely approve it.

Chairman Hearn thanked Mr. Dennis for the report.

## GUEST - MR. JUSTIN POWELL, DORCHESTER COUNTY CHIEF FINANCIAL OFFICER

Mr. Powell reviewed the preliminary unaudited budget report for June 2014. He said the final disbursement had not been received from the State of South Carolina for the Local Government Fund. Additionally, expenditures incurred in June for items delivered in July are being charged back to the prior year, he said.

#### COUNCIL MEMBER'S TIME - MR. LARRY HARGETT

Councilman Hargett reported that constituents from Coosaw Creek Country Club and the Coosaw Creek Homeowners Association contacted him requesting help in identifying locations on the golf course – other than the clubhouse – for EMS to use when responding to 911 calls. Councilman Hargett recommended this request be placed in the Public Safety, Health and Human Services (PSHHS) Committee for further study and consideration of all six golf courses in Dorchester County. PSHHS Committee Chairman Bailey said that since learning about this issue,

Mr. Doug Warren, Dorchester County EMS Director, and Mr. David Garber, Dorchester County GIS Coordinator, have begun working on identifying geographic coordinates for the tee boxes, fairways, greens and corresponding access points for all six golf courses in Dorchester County, as well as points along the Sawmill Branch Trail. PSHHS Committee Chairman Bailey recommended Council receive a report from Mr. Warren and Mr. Garber at a future Council meeting. Councilman Hargett agreed.

COUNCIL MEMBER'S TIME - MR. JAY BYARS

Councilman Byars invited Mr. Beau Ganas of Dixon, Hughes, Goodman, LLP, to address Council regarding the community service project of the 2014 Leadership Dorchester Class of the Greater Summerville/Dorchester Chamber of Commerce. Mr. Ganas said Leadership Dorchester is raising funds to enhance the Sawmill Branch Trail, a 10-foot-wide asphalt path along the canal from East Richardson to the Oakbrook YMCA. Plans call for the installation of four destination points, consisting of water fountains for people and pets, benches, landscaping, trashcans and recycling bins, he said.

Additionally, Summerville Medical Center has donated \$10,000 for the placement of two 10-station fit trails, complete with signage and equipment guiding participants through a series of stretches and conditioning exercises. Preliminary plans have the two fit trails located near the Oakbrook YMCA and Newington subdivision, said Mr. Ganas. Other donations include \$5,000 from Showa Denko and an in-kind contribution of \$7,500 from Thomas and Hutton of Mt. Pleasant. Donations will fund new trail head entrances with kiosks, maps and signage, he said.

Mr. Ganas answered questions from Council, including a question about when the upgrades would be complete. The hardscapes will be installed by early October, and the landscaping will be installed in November to reduce the number of weeks needed to water the new plants, said Mr. Ganas.

In closing, Councilman Byars called the trail a wonderful asset and praised the community-led effort to enhance the usability of the trail for people of all ages. He said Dorchester County is part of an SC Department of Transportation grant that will extend the trail from the Oakbrook YMCA to Dorchester Road, making it even more useful to more people.

3. On the motion of Councilman Bailey, seconded by Councilwoman Duncan, Council voted unanimously to approve \$10,000 in funding from the Dorchester County Recreation Fund to support enhancement efforts by Leadership Dorchester to the Sawmill Branch Trail.

PLANNING AND ZONING FUNDS TRANSFER

4. On the motion of Councilman Davis, seconded by Councilman Chinnis, Council voted unanimously to approve a transfer of \$20,000 from personnel savings to operating in the Planning and Zoning Department to cover the cost of contractual services.

ROAD MAINTENANCE AGREEMENT: REMINISCE SUBDIVISION - PHASE 5A

5. On the motion of Councilman Davis, seconded by Councilman Hargett, Council voted unanimously to authorize the start date of a 12-month maintenance liability period for Reminisce Subdivision — Phase 5A, including Pavilion Street, Tarleton Drive and Calabash Court as identified in the application.

**REZONING REQUEST #689** 

6. On the motion of Councilman Davis, seconded by Councilman Bailey, Council voted six in favor, with one abstention, to approve 1<sup>st</sup> Reading of Rezoning Request #689 and referral to the Planning, Development and Building Committee for further consideration and a recommendation to County Council. Rezoning Request #689 is for Hopper Communities, TMS #128-00-00-021 and TMS #128-00-00-128, to rezone 33.59 acres at the intersection of Orangeburg Road and East Butternut Road from Multi-Family Residential (R-4) and General Commercial (CG) to Planned Development District (PD). Councilman Chinnis abstained from voting.

Chairman Hearn called on Mr. Alec Brebner, Dorchester County Planning and Zoning Manager, to answer questions regarding the absence of a recommendation on this issue from the Planning Commission. Chairman Hearn called to order the meeting of the Dorchester County Council. He invited all to stand for the invocation, which was given by Councilman Davis and followed by the Pledge of Allegiance.

From the audience, Chairman Hearn recognized and welcomed Mr. Richard Rosebrock, retired County Councilman, and Mr. Monty Jones, newly appointed Dorchester County Delinquent Tax Collector.

#### CHAIRMAN'S TIME - MR. WILLIAM R. HEARN, JR.

#### REQUESTS TO ADDRESS COUNCIL:

Mr. Chris Coutant, 208 Terry Avenue, Summerville, thanked Council members for their service to the County. He then asked Council for a completion date regarding the Dorchester Road construction project. He voiced concerns about a lack of progress and asked Council to use any available leverage to get the project moving. He said he owns a business on Dorchester Road. Councilman Byars stated that the Dorchester County Sales Tax Transportation Authority (DCTA) is overseeing the project with meetings held monthly at 7 p.m. on the second Monday in Council Chambers, Summerville. He said the meeting is open to the public.

Ms. Barbara Blake, 121 Luetta Lane, Ridgeville, asked Council when Luetta Lane would be improved. Chairman Hearn stated that the road is not a County road. Mr. Ward said he would follow up with correspondence to Ms. Blake, indicating a course of action for adding the road to the Dorchester

County system of roads.

Mr. Will Limehouse, 2520 Bacons Bridge Road, Summerville, thanked Council for the opportunity to speak. He addressed Council about a dispute with DCTA over his requested installation of an additional drainage pipe as part of the Bacons Bridge Road construction project. He presented Council with a photo of the flooding his yard experienced during a heavy rain and questioned why DCTA and Davis and Floyd would not install the second drainage pipe when they were aware of the problem before construction began. He said because of the road-widening project even more water will flow to his property. He asked Council to install the second pipe in conjunction with the completion of the road project.

Mr. Wayne Hagenbuch, 341 Danby Wood Court, Summerville, asked Council to remove the overgrowth and canopy on West Fischer Road, which connects Highway 17A and Dorchester Road. He stated that this road is used as a cut-through to avoid traffic on Dorchester Road. The overgrowth blocks signage and natural light, making it difficult for drivers to see well and maintain alignment in the

proper lane, he said.

Ms. Peggy Bangle, 114 Ravenwood Court, Summerville, stated she was frustrated with government at all levels. She asked Council to look for ways to reduce spending and consider what could go wrong before making decisions. She recalled the groundbreaking of the Dorchester Road improvement project and statements at the time that it would not be like another Trolley Road or Ladson Road improvement project. She asked Council to consider, when looking at a new project, whether it is government's responsibility or whether a non-profit group or the private sector could take on the project instead.

ADOPTION OF MINUTES

## GUEST - MR. JUSTIN POWELL, DORCHESTER COUNTY CHIEF FINANCIAL OFFICER

#### **BUDGET REPORT FOR JULY 2014**

Mr. Powell presented the July 2014 budget report to County Council and answered questions. Councilman Bailey thanked Mr. Mike Goldston, Dorchester County Interim Public Works Director, and his staff for the in-house work performed in the Archdale subdivision, thereby saving the County from paying an outside contractor fees that came in over bid.

#### FY2013-2014 CARRYOVER BUDGET

2. On the motion of Councilman Hargett, seconded by Councilman Chinnis, Council voted unanimously to approve the FY2013-2014 Carryover Budget as presented.

**RESOLUTIONS #14-08 AND #14-09** 

3. On the motion of Councilman Chinnis, seconded by Councilman Bailey, Council voted unanimously to approve Resolution #14-08, Reimbursement for Jail Furnishings and Equipment Expenditures Not to Exceed \$1.4 Million, and Resolution #14-09, Reimbursement for Jail Facilities Expenditures Not to Exceed \$4.1 Million.

Councilman Chinnis thanked staff for cost savings achieved by considering the usable life and not financing jail furnishings and equipment for 30 years, thereby saving the County money.

<u>GUEST – MRS. ALISON SIMMONS, COMMUNITY DEVELOPMENT MANAGER, DORCHESTER</u> COUNTY ECONOMIC DEVELOPMENT

Mrs. Simmons gave a presentation to County Council on the requirements for offering special property tax assessments for those who rehabilitate qualified historic properties. She asked Council to authorize her to draft an ordinance for consideration.

4. On the motion of Councilman Chinnis, seconded by Councilwoman Duncan, Council voted unanimously to authorize the Community Development Manager with the task of developing recommendations for administrative parameters and – through collaboration with legal counsel, appropriate County departments and interested municipalities – an Ordinance offering special property tax assessments for those who rehabilitate qualified historic properties.

#### **COUNTY ADMINISTRATOR'S TIME**

INTRODUCTION OF MRS. LEONITTA TURNER, DORCHESTER COUNTY HUMAN RESOURCES DIRECTOR

Mr. Ward introduced Mrs. Turner as the new Dorchester County Human Resources Director as of August 25. Previously, she was Human Resources Director for Berkeley County for six years. Mr. Ward said Mrs. Turner has held management positions in both the public and private sectors with Mitsubishi, Honda and the City of Columbus, Ohio. Mrs. Turner holds a Master's degree from Ohio State University and is a Senior Human Resources Professional as designated by the Society for Human Resources Management, he said. County Council led a round of applause in her honor.

YMCA LAND USE AGREEMENT

5. On the motion of Councilman Byars, seconded by Councilman Hargett, Council voted unanimously to defer authorizing the County Administrator to execute a 10-year extension for the YMCA to continue using 15 acres owned by Dorchester County at 900 Cross Creek Drive for recreational activities until the new Dorchester County Parks and Recreation Director can meet with YMCA officials.

Councilman Byars said he wanted the newly hired Dorchester County Parks and Recreation Director to meet with YMCA officials before Council takes action on this item.

<u>PART-TIME ADMIN I POSITION IN MAGISTRATE'S COURT TO ADDRESS INCREASING EXPUNGEMENT REQUIREMENTS</u>

6. On the motion of Councilman Bailey, seconded by Councilman Davis, Council voted three in favor – with two opposed and two abstaining – to authorize the establishment of a temporary, part-time Admin I position in the Magistrate's Office to assist with the expungement of criminal records, in accordance with Act No. 276 of 2014 of the General Assembly of the State of South Carolina. The motion passed with Councilman Hargett and Councilman Davis voting no and Councilwoman Duncan and Councilman Chinnis abstaining from voting.

Mr. Ward said the Magistrate's Office was notified of the order from the Supreme Court of South Carolina after the passage of the state's budget and after the passage of the County's budget.

Before the vote, Councilwoman Duncan offered a motion, seconded by Councilman Chinnis, to delay voting until the facts could be gathered regarding a report of a magistrate judge being paid a full-time salary while working part-time hours. As he seconded the motion, Councilman Chinnis stated he was aware of the same report, and questioned whether the Magistrate's Office could find the money for the part-time admin position in the budget.

During discussion, Councilwoman Duncan stated that while County Council has no authority over magistrate judges, taxpayer money is at stake; and Council needs to be able to provide the public with answers. Councilman Bailey said that questions about a magistrate judge should be addressed by the local senatorial delegation, and Council should stick to the agenda. Councilwoman Duncan and Councilman Chinnis said the questions relate to the budget, for which County Council is responsible.

Chairman Hearn recognized The Honorable Katrina Patton, Chief Magistrate, from the audience. She said all magistrate judges are up for reappointment and that the issue raised is being addressed. Judge Patton said the potential exposure from just one lawsuit would justify the \$11,000 expenditure to comply with the Expungement Act, which took effect June 12.

At the conclusion of discussion, Councilwoman Duncan withdrew her motion, and Councilman Chinnis withdrew his second, saying he would refrain from voting on another unfunded mandate.

Chairman Hearn thanked Judge Patton.

SOLID WASTE USER FEE BILLING ON OWNER-OCCUPIED COMMERCIAL PROPERTIES Mr. Ward reported to Council that the County will include the Solid Waste User Fees for owner-occupied commercial properties on the tax bills in accordance with the Code of Ordinances of Dorchester County, Section 34-66. A list of the affected properties was provided to Council. Mr. Ward said the County bills for residential Solid Waste User Fees in the same manner.

Councilman Bailey asked for a percentage of delinquent properties. Mr. Ward said he did not have a percentage but that some – including government agencies – have been delinquent for several years. Including the fee on the tax bills will allow the County to sell the delinquent properties at a delinquent tax sale, he said.

#### COMMITTEE REPORTS

<u>DORCHESTER COUNTY SALES TAX TRANSPORTATION AUTHORITY ORDINANCE</u>
Councilman Chinnis made a motion, seconded by Councilwoman Duncan, to give 3<sup>rd</sup> Reading and final approval of Ordinance #14-12, amending the Dorchester County Sales Tax Transportation Authority (DCTA) Ordinance to revert back to the original structure of seven members.

Councilman Bailey recognized Mr. Randy Patrick from the audience and thanked him for his service as a member of the DCTA, saying he would be rotating off the Board upon the adoption of the new ordinance because Mr. Patrick is an at-large member.

Councilman Chinnis questioned whether Mr. Patrick would be the member rotating off the board. He requested that at the next County Council meeting each Council member ask for the appointment of a member to return the DCTA to seven members.

Councilman Bailey said it was his understanding that when Council increased the Board from seven to nine members, Mr. Patrick was one of the extra two. The second at-large seat was left vacant by the July resignation of Mr. Robby Robbins.

Councilman Chinnis restated his request that at the next County Council meeting on September 15, each member of Council have a recommendation for an appointee to the DCTA to be voted on by full Council. He said he hoped someone would select Mr. Patrick. He reminded Council of the speakers this evening during public time. While we as a Council are not letting these road contracts, our obligation is that we are appointing people to the DCTA who serve at our will and who should understand that the will we impart to them is the will of the people we represent; and they should represent those people in a like manner, he said.

Councilman Hargett said he did not see in the new ordinance anything requiring Council to reappoint members. Chairman Hearn said that while it is not in the ordinance Council could decide by majority vote to contact each member of the DCTA and ask them to reapply.

Councilman Byars noted that DCTA members serve on a pro bono basis and Council members should ask their appointees if they want to continue serving. Because it is a lot of work, some may not want to continue serving. He said Council should also evaluate whether it is time for some fresh eyes on the road projects, saying a lot of taxpayer money is at stake and the general feeling of the public is that no one is in control. He said he would support Council voting to reappoint seven members.

Chairman Hearn asked for clarification of the ordinance.

Mr. Frampton said the ordinance currently provides that the term of the DCTA office will be coterminous with the term of the Council member making the nomination. He said the ordinance further provides that a member can be removed by a majority vote of County Council.

Mr. Ward clarified with Mr. Frampton that upon 3<sup>rd</sup> Reading of the ordinance in its current form, it was uncertain who would be the members serving at the September 8 meeting of the DCTA without subsequent action by Council.

- 20. On the motion of Councilman Chinnis, seconded by Councilwoman Duncan, Council voted unanimously to amend the proposed ordinance to defer the effective date until September 16.
- 21. On the motion of Councilman Chinnis, seconded by Councilwoman Duncan, Council voted unanimously to give 3<sup>rd</sup> Reading and final approval of Ordinance #14-12 as amended above to become effective September 16 amending the Dorchester County Sales Tax Transportation Authority (DCTA) Ordinance to revert back to the original structure of seven members.

Councilman Chinnis offered a motion, seconded by Councilman Byars, that at the next regularly called meeting of County Council, Council would open the floor and nominate seven members of the DCTA. There was some discussion. Councilman Chinnis and Councilman Byars withdrew their motion and second.

Councilman Hargett and Councilman Davis voted against the motion.

Chairman Hearn called to order the meeting of the Dorchester County Council. He invited all to stand for the invocation, which was given by Councilman Hargett and followed by the Pledge of Allegiance.

#### CHAIRMAN'S TIME - MR. WILLIAM R. HEARN, JR.

#### REQUESTS TO ADDRESS COUNCIL:

 Mr. Stephen Haws, 717 Professor Drive, Eagle Run subdivision, Ladson, stated concerns about the Oakbrook Convenience Site on Old Fort Road. He said he returned home from work at 1 a.m. Saturday and woke up at 6:20 a.m. because of noise from a dumpster being emptied. Mr. Haws requested Council action on the following: to establish and enforce dumpster pick-up times, to adopt guidelines restricting contractors from using the site and reserving usage by Dorchester County residents only for residential purposes only, and to implement a plan for litter control along Old Fort Road and the surrounding woods. As a long-range solution, he asked Council to consider relocating the Oakbrook Convenience Site to a commercial district. In the interim, he recommended removing the dumpsters from the back of the site, constructing a sound barrier and compensating the residents.

- Mr. Will Limehouse, 2520 Bacons Bridge Road, Summerville, stated concerns about the accountability of the Dorchester County Sales Tax Transportation Authority (DCTA) to the taxpayer. He also stated concerns about a retention pond enlarged as part of the Dorchester Road construction project and the pond's potential for flooding Tasker Drive because of what he described as an inadequate pond wall. He submitted pictures of flooding on his property to the Chairman.
- Ms. Barbara Mojonnier, 221 Brandywine Drive, Summerville, stated concerns about appointees to the DCTA not living in the District they represent. She said she supports returning the DCTA to seven members. She made three requests: each Council member should appoint a resident of the District to serve on DCTA with the name and contact information of the appointee publicly available, the appointee should have verifiable educational and/or employment experience that is relevant to the decisions made by the DCTA and District residents should be notified when there is a vacancy.
- Ms. Peggy Bangle, 114 Ravenwood Court, Summerville, asked Council to consider job sharing for part-time employees to fill full-time positions. She also asked Council to consider all obstacles and potential for problems before spending tax money.

If certified, the Department of Commerce will reimburse the County for half of the application fee and Step 3 costs for a net cost of \$53,392.

#### ON-CALL POLICY: ANIMAL CONTROL OFFICERS

7. On the motion of Councilman Chinnis, seconded by Councilwoman Duncan, Council voted six in favor, with one absent, to approve an on-call policy for Animal Control Officers to be paid \$15 a day for being on-call on nights and weekends and to receive a minimum hour of pay for each call that requires the use of a vehicle. Councilman Davis was absent.

Mr. Powell said this is consistent with the on-call policy presently in Water and Sewer.

## RESOLUTION #14-11, AMENDING THE POLICY OF HOME GARAGING COUNTY VEHICLES

8. On the motion of Councilman Bailey, seconded by Councilman Chinnis, Council voted six in favor, with one absent, to approve Resolution #14-11, which adds Animal Control Officers to the list of designated employees for the home garaging of County vehicles as outlined in Resolution #14-02. Councilman Davis was absent.

## CHAIRMAN CHINNIS - PLANNING, DEVELOPMENT AND BUILDING COMMITTEE

Chairman Chinnis reported that the Committee met at 6:30 p.m. to review one request.

9. As recommended by the Committee, Council voted six in favor, with one absent, to approve 2<sup>nd</sup> Reading of Rezoning Request #684 for The Ryland Group for portions of TMS #160-00-056, TMS #160-00-00-081 and TMS #160-00-00-082 to rezone 51.8 acres of undeveloped land on Beech Hill Road from Multi-Family Residential (R-4) and Commercial-Light Industrial (CLI) to Planned Development District (PD). Councilman Davis was absent.

Councilman Chinnis said there were discussions with Mr. Alec Brebner, Dorchester County Planning and Zoning Manager, and if there are further changes needed, then Council as a whole could discuss that at 3<sup>rd</sup> Reading.

#### CHAIRMAN HEARN – WATER AND SEWER COMMITTEE

Chairman Hearn passed the gavel to Vice Chairman Bailey before giving his Committee report. Chairman Hearn reported that the Committee met at 6:45 p.m. to consider two requests.

On the motion of Councilman Hargett, seconded by Councilman Chinnis, Council voted six in favor, with one absent, to give 3rd Reading and final approval of Ordinance #14-14, authorizing, pursuant to Chapter 44 of Title 12, South Carolina Code of Laws, 1976, as amended, the execution and delivery of a Fee Agreement between Dorchester County, South Carolina, and Innovative Machining Technology, Inc.; and matters relating thereto. Councilman Davis was absent.

#### <u>MULTI-COUNTY INDUSTRIAL PARK: KEYSTONE INDUSTRIAL CORP. AND INNOVATIVE</u> MACHINING TECHNOLOGY, INC.

On the motion of Councilman Chinnis, seconded by Councilwoman Duncan, Council voted six in favor, with one absent, to give 3<sup>rd</sup> Reading and final approval of Ordinance #14-15, amending the agreement for development of a Joint County Industrial Park by and between Dorchester County, South Carolina, and Orangeburg County, South Carolina, providing for development of a Joint County Industrial Park so as to include property of Keystone Industrial Corporation and Innovative Machining Technology, Inc., and other matters related thereto. Councilman Davis was absent.

Chairman Hearn struck the gavel, opening the Public Hearing. He invited the public to come forward to speak on this issue. In the absence of any requests to speak, Chairman Hearn struck the gavel again, closing the Public Hearing.

14. On the motion of Councilwoman Duncan, seconded by Councilman Chinnis, Council voted six in favor, with one absent, to give 3<sup>rd</sup> Reading and final approval of Ordinance #14-16, authorizing delivery by Dorchester County of a Special Source Revenue Credit Agreement with Keystone Industrial Corporation and other matters related thereto. Councilman Davis was absent.

#### FILOT: SPEC-CON

15. On the motion of Councilman Chinnis, seconded by Councilman Bailey, Council voted six in favor, with one absent, to give 2<sup>nd</sup> Reading to an Ordinance authorizing a Fee In Lieu of Tax and Incentive Agreement

and Special Source Revenue Credit (SSRC) Agreements by and between Dorchester County and Spec-Con, LLC. Councilman Davis was absent.

Mr. Frampton said the agreements include a six percent assessment on the machinery and equipment for 20 years, a 10 percent SSRC on the machinery and equipment for the first five years and an SSRC for 20 years on the building, which is equivalent to a six percent assessment on the building.

#### MULTI-COUNTY INDUSTRIAL PARK ORDINANCE: SPEC-CON

16. On the motion of Councilman Chinnis, seconded by Councilwoman Duncan, Council voted six in favor, with one absent, to give 2<sup>nd</sup> Reading for approval of an Ordinance to amend the Multi-County Industrial Park to include property owned by Spec-Con, LLC. Councilman Davis was absent.

#### **EXECUTIVE SESSION**

The County Attorney requested Council's consideration to enter into Executive Session to discuss the following:

Councilman Davis was absent.
- 18. On the motion of Councilman Chinnis, seconded by Councilman Hargett, Council voted six in favor, with one absent, to vote on the main motion of entering into Executive Session to discuss the announced items. The time was approximately 7:43 p.m. Councilman Davis was absent.

#### RECONVENE FROM EXECUTIVE SESSION

At approximately 7:58 p.m., the County Attorney reported that Council discussed the previously announced item, but no action was taken.

Councilman Hargett stated: Effective tomorrow, the Sales Tax Transportation Authority will revert back to its seven-member composition as it was originally created by Ordinance Number 2005-03. Currently, however, there are eight members of the Authority, one of which was appointed by Council as a whole. That member is Randy Patrick. Because Mr. Patrick was appointed to the Authority as one of the two additional members created pursuant to Ordinance 11-07, and since the Authority is now reverting back to its original composition, I would move that County Council remove Randy Patrick from the Authority.

19. On the motion of Councilman Hargett, seconded by Councilman Chinnis, Council voted six in favor, with one absent, to remove Mr. Randy Patrick from the Dorchester County Sales Tax Transportation Authority. Councilman Davis was absent.

During discussion, Councilman Byars said Mr. Patrick has done a phenomenal job, and this is not a reflection on him. As a professional engineer, he brought a lot of experience to the table, said Councilman Byars. He thanked Mr. Patrick for his service. Other Council members offered words of thanks and praise for Mr. Patrick's service on the DCTA.

#### APPOINTMENTS TO BOARDS AND COMMISSIONS:

Councilman Chinnis announced that his appointee Mr. Jordan Bryngelson has resigned from the DCTA.

- 20. On the motion of Councilman Chinnis, seconded by Councilman Byars, Council voted six in favor, with one absent, to appoint Mr. Russ Touchberry, 111 Presidents Circle, Summerville, to the DCTA.

  Councilman Davis was absent.
  - Councilman Chinnis said that although Mr. Touchberry does not live in his District, he does have the knowledge base to serve on the DCTA. He said Mr. Touchberry is an engineer, a graduate of the Citadel and a former SCDOT employee.
- 21. On the motion of Councilwoman Duncan, seconded by Councilman Chinnis, Council voted six in favor, with one absent, to remove Mr. Mark Pilgrim from the DCTA. Councilman Davis was absent.
  - Councilwoman Duncan said she truly appreciates Mr. Pilgrim's service on the DCTA and the many accomplishments during his time of service. She said she wanted to appoint someone with the education, expertise and vast knowledge of road construction and infrastructure.
- 22. On the motion of Councilwoman Duncan, seconded by Councilman Chinnis, Council voted six in favor, with one absent, to appoint Mr. Matt Halter to the DCTA. Councilman Davis was absent.
  - Councilwoman Duncan said many know Mr. Halter as the former Dorchester County Public Works Director. He is an engineer who formerly worked for the City of Charleston and now works in the private sector. She said he brings education, expertise and experience to the position.
  - Councilman Chinnis asked for the support of Council and Mr. Frampton in writing and adopting a motion that allows Council to require the members of any Committee in Dorchester County where those members directly spend County money to provide a statement of economic interest and proof of County residency.
  - Councilman Bailey said the status of the remaining DCTA members is unchanged. They will continue to serve. Chairman Hearn thanked Councilman Bailey for his remarks and said the four DCTA members appointed by Council members standing for re-election in November will be due for reappointment in January.
- 23. On the motion of Councilwoman Duncan, seconded by Councilman Chinnis, Council voted six in favor, with one absent, to reappoint Mr. Walter Limehouse to the Dorchester County Board of Assessment Appeals. Councilman Davis was absent.

Councilman Davis was absent.

On the motion of Councilman Bailey, seconded by Councilwoman Duncan, Council voted six in favor, with one absent, to provide the Claims Assistant a temporary 10 percent increase in pay during the vacancy of the Risk Manager position for additional duties required during the interim.
