MINUTES DORCHESTER COUNTY COUNCIL DORCHESTER COUNTY HUMAN SERVICES BUILDING COUNCIL CHAMBERS, SUMMERVILLE JANUARY 5, 2015 7:00 P.M.

Chairman Hearn called to order the meeting of the Dorchester County Council. He invited all to stand for the invocation, which was given by Councilman Hargett and followed by the Pledge of Allegiance.

CHAIRMAN'S TIME

Chairman Hearn congratulated Mr. J.J. Messervy, Dorchester County Auditor, on the January 4 birth of his second son, Jacob Hamilton Messervy. Mr. Messervy reported that mother and baby were doing well.

ELECTION OF CHAIRMAN

Chairman Hearn then opened the floor for nominations of a new Chairman of County Council to serve a two-year term. Councilman Byars nominated Councilman Chinnis, which was followed by multiple seconds as led by Councilman Bailey. In the absence of any additional nominations, Chairman Hearn closed the floor for nominations.

When the Chairman called for the vote, Councilman Chinnis said he was told once that if you can't vote for yourself, then don't expect anyone else to vote for you. He thereby broke a longstanding tradition of nominees abstaining from voting by raising his right hand, making the vote unanimous. Outgoing Chairman Hearn congratulated the newly elected Chairman Chinnis and led a round of applause.

For the record, the vote was as follows:

1. On the motion of Councilman Byars, seconded by Councilman Bailey, Council voted unanimously to elect Mr. David Chinnis as Chairman for a two-year term.

Chairman Chinnis thanked Councilman Hearn for his tenure on Council and his leadership as Chairman.

Councilman Hearn thanked Council and Staff for their work over the past two years. He recognized and thanked his family in attendance, including his wife, Libby; daughters, Brooks and Sarah; his parents Bill and Jane Hearn; and brother, David Hearn. He also thanked his paralegal, Mrs. Sue Gregory and her husband. He thanked Mrs. Faith Sellers of Dorchester Seniors, Mr. J.J. Messervy, Mr. Ryan Castle and his predecessor, former District #6 Councilman Mike Murphree.

Councilman Hearn offered best wishes to Chairman Chinnis, noting not that he needs the wishes but saying the job is challenging at times. Councilman Hearn predicted that the best days for Dorchester County are truly ahead of us and thanked everyone for the years of work in getting Dorchester County ready. In particular, Councilman Hearn thanked Mr. Ward, saying he has never met anyone who has such a command of county operations and called Mr. Ward an unsung hero.

ELECTION OF VICE CHAIRMAN

Chairman Chinnis opened the floor for nominations of a Vice Chairman of County Council to serve a two-year term. Councilman Davis nominated Councilman Bailey for a second term as Vice Chairman. Councilwoman Duncan quickly seconded the motion. In the absence of any additional nominations, Chairman Chinnis closed the floor for nominations.

When the Chairman called for the vote, Councilman Bailey started to abstain from voting for himself but was encouraged by his colleagues to raise his right hand, continuing a new tradition of electing Council officers by unanimous vote.

For the record, the vote was as follows:

2. On the motion of Councilman Davis, seconded by Councilwoman Duncan, Council voted unanimously to re-elect Mr. George Bailey as Vice Chairman for a two-year term. Chairman Chinnis congratulated Vice Chairman Bailey and led a round of applause.

Vice Chairman Bailey said he had little to add to Councilman Hearn's remarks, but said he has learned from Mr. Ward that papers remember, minds forget. He thanked Mr. Ward for his hard work and paper trail of documentation. Vice Chairman Bailey also thanked all County employees and said he looks forward to working with Council and Staff for two more years.

Chairman Chinnis said he wanted to echo the remarks of Vice Chairman Bailey and Immediate Past Chairman Hearn, saying he was not entirely certain he would have accepted the nomination as Chairman if Mr. Ward was not the Administrator. Chairman Chinnis thanked County employees, who he said probably don't get thanks enough but catch it when things don't go well. He said there would be an opportunity later in the agenda to thank employees for their long service. He closed his remarks by thanking his family and recognizing members who were in the audience: his wife, Barbie; his son, Micah; his parents, Ed and Joan Chinnis; and his grandmother, Mrs. Margaret Blackmon. He said he could not serve as Chairman without their support.

REQUESTS TO ADDRESS COUNCIL:

- Ms. Barbara Blake, 121 Luetta Lane, Ridgeville, addressed Council, requesting improvements to Luetta Lane, a private road.
- Mr. John Allen, 11093 Dorchester Road, Teal on the Ashley, Summerville, asked Council to reduce the speed limit from 35 miles per hour to 25 and post speed limit signs, install a guardrail and reflector tape, improve the ditches, install "Watch for Children" signs and install a stop sign.
- Mr. Clint Ashley, 686 W. Butternut Road, Summerville, asked if there has ever been an engineering study regarding drainage in Pine Hill Acres. He said additional ditches are not needed, and there is no drainage problem. He asked Council to spend the money instead on paving Knight Avenue.
- Mr. Mike Murphree, a former Dorchester County Councilman, congratulated the new Chairman. He voiced support for Resolution #15-01, regarding critical area permitting regulations, and asked Council to adopt it.
- Ms. Kimberly Sprecher, 118 Knight Avenue, Pine Hill Acres, Summerville, spoke against the proposed ditch, saying her land does not flood.
- Ms. Shelby Mundy, 120 Knight Avenue, Pine Hill Acres, Summerville, said she has a privacy fence and buildings on her property that would be impacted by a ditch. She asked Council not to install a ditch, saying she does not have a flooding problem.
- Mr. Tom Hall, 209 Swanson Drive, Summerville, asked Council to pave Knight Avenue. He
 recommended cleaning existing ditches rather than installing new ditches to alleviate the water
 problem.
- Ms. Debbie Ainscough, 189 McMakin, Summerville, said her yard floods. She asked for Council support in diverting water away from her property. She said it is a shame that residents do not want to support a plan to better their community when the County is offering to help.
- Ms. Peggy Bangle, 114 Ravenwood Ct., Irongate, Summerville, congratulated the new Chairman and the re-elected Vice Chairman. She spoke on the topics of roads and the Local Government Fund and continuity of services among various levels of government.

ADOPTION OF MINUTES

3. On the motion of Councilman Davis, seconded by Councilman Hargett, Council voted unanimously to adopt the minutes from the December 1, 2014, County Council meeting.

DORCHESTER COUNTY EMPLOYEE LONGEVITY PROGRAM

Dorchester County recognized and thanked employees for achieving years-of-service milestones during the last quarter of 2014. Mrs. Leonitta Turner, Human Resources Director, along with Mr. Ward and County Council, presented the following employees with pins and certificates. With five years of service, the County recognized Mr. Bryan Hodges, Mr. Eric Phillips and Mr. Joseph Pirkel of EMS and Mr. Matthew Carter of the Sheriff's Department. With 15 years of service, the County recognized Mrs. Alice Durr of the Coroner's Office. With 20 years of service, the County recognized Mr. Michael Giglio and Mr. Terrance VanDoran of the Sheriff's Department.

DORCHESTER COUNTY EMPLOYEE OF THE YEAR

County Council recognized Mr. Terry Roberts of the Public Works Department as the 2014 Employee of the Year. Mr. Roberts, a motor equipment operator in the Transportation Division, has been a Dorchester County employee since 2006. Mr. Ward said Mr. Roberts is an asset to the County and helps train other

truck drivers to obtain their Commercial Driver's License (CDL). County Council presented him with a plaque and led a round of applause.

RESOLUTION #15-01

4. On the motion of Councilman Bailey, seconded by Councilman Davis, Council voted unanimously to adopt Resolution #15-01, a Resolution Requesting the Dorchester County Legislative Delegation to Initiate Legislation to Exempt a Portion of Dorchester County from "Critical Area Permitting Regulations."

DRAFT CRDA BYLAWS

5. On the motion of Councilman Bailey, seconded by Councilman Hearn, Council voted unanimously to adjourn the issue for two weeks until the Monday, January 20, County Council meeting.

CORRESPONDENCE: Mr. Ward reported that staff forwarded items of correspondence upon receipt.

GUEST: MR. JUSTIN POWELL, DORCHESTER COUNTY CFO, NOVEMBER 2014 BUDGET REPORT

Mr. Powell presented the November 2014 budget report. He included a summary of revenues and expenditures for the County's major funds through November 30. He gave a summary of cash on hand in the major funds and status updates on major water/sewer and stormwater projects. Additionally, Mr. Powell reported that the County received, on New Year's Eve, the final payment of \$1.9 million in reimbursement from FEMA (Federal Emergency Management Agency) because of the February 2014 ice storm. Mr. Powell thanked Mrs. Tammie Sullivan and her team in the Finance Department for steering the County through this anticipated year-long process in only 10 months. There were no questions.

GUEST: MR. JOHN TRULUCK, DORCHESTER COUNTY ECONOMIC DEVELOPMENT DIRECTOR

Mr. Truluck reported that on December 8 Dorchester County was recognized as one of 18 counties to achieve the certified Work Ready Community certificate, which brings the total to 24 counties in South Carolina that have attained this designation out of 36 counties nationwide. He said Dorchester County is among the first group of large counties in the state to achieve the certification. In order to become certified, Dorchester County had to have cooperation from the school districts, business and industry and the local workforce. He said this demonstrates that Dorchester County has trained workers available for economic development partners looking to expand or locate here. He thanked Vice Chairman Bailey for traveling with him to Columbia to accept the award. He also thanked Mrs. Wendy Smith for her work in helping Dorchester County earn this distinction.

Councilman Hearn noted that in the past the four critical components for economic development were roads, sewer, water and rail. The fifth element is now workforce. He said he is very proud of what Dorchester County Economic Development is doing in this area, saying it shows industries in the state, country and world that we are serious about workforce development.

GUEST: MS. DIANA SAILLANT, OWNER OF SAILLANT LANGUAGE CONSULTING

Ms. Saillant provided information to County Council on the growth of the Hispanic population and culture in the tri-county area. She presented the Five Universal Latino Truths: (1) Family Comes First, (2) Technology is a Cultural Enabler, (3) Food is for Bonding, (4) Language is a Connector and (5) Culture Will Continue. She thanked Ms. Jacobs, Deputy Administrator, for inviting her to speak to Council. Councilman Davis thanked her for her presentation and invited her to the Martin Luther King, Jr., parade to be held in St. George on Sunday, January 18. Councilman Hargett noted that his church, Summerville Baptist, has been involved for five years teaching English as a second language with more than 100 Latinos attending this free seminar.

COUNCIL MEMBER'S TIME - MR. LARRY HARGETT

Councilman Hargett introduced to County Council Mr. Michael Gray, a District #4 resident. Mr. Gray is an outstanding senior at Old Fort High School. He is one of two students in the state of South Carolina to receive an appointment to the United States Air Force Academy, beginning in the 2015-2016 term. He has a 4.0 grade point average, runs track and participates in the U.S. Air Force Junior ROTC at Old Fort High School. His parents served

a combined total of 53 years in the Air Force. Mr. Gray thanked Mr. Hargett and Council for the recognition and said he is ready to serve his country.

COUNTY ADMINISTRATOR'S TIME - MR. JASON WARD

EMPLOYEE RECRUITMENT, SELECTION & ORIENTATION PROCESSES

6. On the motion of Councilman Davis, seconded by Councilwoman Duncan, Council voted unanimously to approve, as presented, the new processes recommended by the Human Resources Director and the CFO.

Mr. Ward said the purpose of these policies is to streamline the recruitment, interview and selection processes. HR will assist departments with the recruitment process and will only make conditional offers of employment after completing professional reference checks and criminal background checks. HR will also schedule new employee orientations to cover employment policies such as anti-harassment, phone and computer use, workers' comp, etc.

DETENTION CENTER STAFFING

7. On the motion of Councilman Davis, seconded by Councilman Bailey, Council voted unanimously to authorize nine new positions in the Detention Center and authorize the hiring for these positions beginning in February 2015.

Mr. Ward said current-year personnel savings in the Sheriff and Detention Center budgets will cover the cost of these new positions through June 30, 2015, and annual funding for these positions will be included in the FY2016 budget, if approved.

During discussion, Councilman Davis said he hopes the County can get to a point where we build more schools rather than spend money on new jails. He advocated for more money on the front end for schools rather than paying dearly on the back end for jails. Councilman Byars spoke in favor of more libraries and playgrounds as well.

EMS MEDIC TWO STATION

8. On the motion of Councilman Hearn, seconded by Councilman Davis, Council voted unanimously to authorize, as amended, the County Administrator to enter into negotiations with three property owners, rather than two, and begin due diligence for the purchase of one property for a new EMS Medic Two Station.

Mr. Ward said the current station is inadequate, and the County Attorney advised against the purchase of the site adjacent to Summerville's fire station because of covenants and restrictions.

FUNDS TRANSFER REQUEST

9. On the motion of Councilman Davis, seconded by Councilman Hargett, Council voted unanimously to transfer \$5,000 from salary savings in the Finance Department for the purpose of implementing Naviline Financial Software.

Mr. Ward said this is a Windows-based version of the County's HTE financial system that will provide greater functionality for users.

MERIT INCREASE CLARIFICATION

10. On the motion of Councilman Davis, seconded by Councilman Hearn, Council voted unanimously to approve a clarification in the 2014-2015 merit increase guidelines.

Mr. Ward said this clarification outlines the process for establishing one merit award date (January 1) for all employees. It specifies how the merit will be implemented for each group of employees. There is no increase in the cost of implementation.

1ST READING: CIP FOR ROADWAYS

11. On the motion of Councilman Hargett, seconded by Councilman Davis, Council voted unanimously to give 1st Reading to an Ordinance to amend the Capital Improvements Plans for Roadways to advance and complete non-motorized Bacons Bridge Road capacity improvements and to refer this ordinance to the Planning Commission and the Planning, Development and Building Committee of County Council for public hearing and recommendations to County Council.

Mr. Ward said if this amendment is approved, transportation impact fee proceeds would be used to fund the construction of the multi-use path down SC Highway 165, connecting the upper and lower projects.

SALE OF SHERIFF'S CRUISERS TO TOWN OF ST. GEORGE

12. On the motion of Councilman Davis, seconded by Councilman Bailey, Council voted unanimously to authorize the County Administrator to sell two 2008 Crown Victoria patrol vehicles (Asset Numbers 12434 and 12431), which have been scheduled for replacement, to the Town of St. George at a cost of \$4,000.

FEE EXPENDITURE REQUEST

13. On the motion of Councilman Hearn, seconded by Councilman Hargett, Council voted unanimously to approve the use of \$14,950 in Treasurer bad check fees for additional auditing services and Treasurer expenses of upgrading cash drawers and purchasing additional checks from First Citizens Bank.

Councilwoman Duncan asked about the possibility of switching banks due to the high cost for more checks. Mr. Powell said historically the cost of new checks has been included as part of our banking engagement. He said it is the discretion of the Treasurer to issue an RFP to reconsider the County's banking relationship. Mr. Powell said staff is available to assist if she chooses that path.

COMMITTEE REPORTS

CHAIRMAN CHINNIS - PLANNING, DEVELOPMENT & BUILDING COMMITTEE

Chairman Chinnis passed the gavel to Vice Chairman Bailey before giving his Committee report. He said the PDB Committee met at 6:15 p.m. and held Public Hearings on Rezoning Requests #695 and #696. No one from the public spoke at either public hearing, and the Committee voted unanimously to recommend full Council approves 2nd Reading, said Chairman Chinnis.

Chairman Chinnis called to order the meeting of the Dorchester County Council. He invited all to stand for the invocation, which was given by Councilman Byars and followed by the Pledge of Allegiance.

CHAIRMAN'S TIME

Chairman Chinnis recognized Councilman Hearn, who asked for a moment of silence in memory of Mr. Matthew Fineran. Mr. Fineran, a former Summerville police officer, was killed on January 29 during a terrorist attack at the Kabul, Afghanistan, international airport, where he was working security as a Department of Defense contractor. A moment of silence was observed.

REQUESTS TO ADDRESS COUNCIL:

- Mr. J.D. Allston of Summerville thanked Council for the moment of silence, saying he once worked with Mr. Fineran. He said Mr. Fineran will be missed. Mr. Allston said his purpose in speaking during public time tonight was to provide Council with an update on the Dorchester County Sales Tax Transportation Authority (DCTA) road improvement projects. Mr. Allston is the Vice Chairman of the DCTA. He gave status updates on in-progress road construction projects funded through the penny sales tax referendum. He suggested moving the completion date forward when road projects experience extended delays due to bad weather or utility relocation delays. Mr. Allston said for the month of January, he has received two complaints from the public regarding road construction projects, which were addressed. He thanked Councilwoman Duncan for her assistance and asked that she be designated a liaison between DCTA and County Council. Councilman Byars said these road projects are in his district, and he needs direct contact with DCTA. Chairman Chinnis clarified that on Bacons Bridge Road the bridge work is delayed by a year, but the paving is on schedule. Councilman Byars thanked Mr. Allston and the DCTA for getting the Cooks Crossroads intersection completed early. He said completion of the Limehouse intersection would alleviate complaints.
- Mr. Wallace E. Kizer, 134 Mill Branch Road, St. George, highlighted the history of the Kenneth F.
 Waggoner Services Center building and thanked Council for approving the placement of a historical marker on the property.

Chairman Chinnis noted that Byron Maxwell, a graduate of Fort Dorchester High School, played for the Seattle Seahawks in his second straight Super Bowl football game. He said he was proud to see a product of Dorchester County in the game even though the final score did not turn out in his favor. Councilman Hearn noted that the loss was not his fault.

Mr. Formisano reviewed the requirements of the Hazard Mitigation Plan and outlined the schedule to update the plan by November. The purpose of the plan is for the County to organize resources, assess risks, develop a mitigation plan, implement the plan and monitor progress, thereby making Dorchester County less vulnerable and more resilient.

GUESTS: SHERIFF L.C. KNIGHT AND MR. ROGER DANGERFIELD, DORCHESTER COUNTY COMMUNICATIONS MANAGER

Beginning this spring, the Dorchester County 911 dispatch center will accept 911 texts, videos and photos through a new tri-county program initiated by the Charleston County dispatch center, said Sheriff Knight. The cost to Dorchester County will be approximately \$30 per work station. While initially reluctant to adopt the program because of concerns of placing an additional burden on dispatchers, Sheriff Knight said he was swayed by that fact that persons who are hearing impaired or in a hostage situation would have a means to contact 911.

Mr. Dangerfield provided additional information about the technical aspects of the program and the plans to educate the public about the new program.

GUEST: MRS. PHYLLIS HUGHES, DORCHESTER COUNTY ARCHIVES AND HISTORY CENTER

Mrs. Hughes spoke on behalf of the board of directors of the Upper Dorchester County Historical Society as well as the newly organized Dorchester County Archives and History Center. Chairman Chinnis called to order the meeting of the Dorchester County Council. He invited all to stand for the invocation, which was given by Councilman Hearn and followed by the Pledge of Allegiance.

CHAIRMAN'S TIME

Chairman Chinnis announced that during the EMS Symposium, Dorchester County received the PIER Award (Public Information, Education and Relations), recognizing the excellent work that everyone in the department does in the community education arena. He congratulated everyone involved and recognized Ms. Megan White for her leadership of the program. Council led a round of applause.

REQUESTS TO ADDRESS COUNCIL:

- Mr. John Allen, 11093 Dorchester Road, Teal on the Ashley, Summerville, asked about Dorchester Road construction. He also asked for Council assistance in getting SCDOT to post "Watch for Children" signs, reduce the speed limit, post a guardrail on the Dorchester Road cut-through and post a "Sharp Curve Ahead" sign.
- Ms. Peggy Bangle, 114 Ravenwood, Summerville, discussed the Local Government Fund (LGF). This refers to local tax dollars collected by the counties and sent to the state with a statutory requirement that 4.5 percent of the state's general fund of the previous fiscal year be returned to the counties to pay for state-mandated services, such as court systems, jails, and election offices. She gave a brief history of the reduction in the percentage of LGF monies returned to the counties over the past six years and the status of LGF bills currently pending in the state legislature.
- Mr. Thomas Feagin, 113 Ponderosa Road, Summerville, asked for Council assistance in ensuring the enforcement of codes regarding property at the corner of Marie Drive and Ponderosa Road, TMS #128-11-02-002.00C, which until recently had a block house plus three mobile homes on a lot that is 0.85 acres in a TRM zoning district.

ADOPTION OF MINUTES

1. On the motion of Councilman Davis, seconded by Councilwoman Duncan, Council voted unanimously to adopt the minutes from the February 17, 2015, County Council meeting.

CORRESPONDENCE: Mr. Ward reported that the budget calendar was sent to Council as a reminder of upcoming retreat dates.

GUEST: MR. WAYNE WELCH, DORCHESTER COUNTY ASSESSOR, PRESENTATION ON 2015 REASSESSMENT

Mr. Welch reported that reassessment in Dorchester County was postponed for one year, from 2014 to 2015, because of the implementation of new computer software, Computer Assisted Mass Appraisal System (CAMA). Even though implementation was postponed, the date of appraisal – December 31, 2013 – still applies. He said the next reappraisal will be for the 2019 tax year, which puts Dorchester County back on the previous schedule as set by the Department of Revenue.

Mr. Welch reported that his office has completed the appraisal of approximately 64 percent of the parcels in Dorchester County as of February 20 with a target finish date of July 31. He said assessment notices will be mailed in August. Taxpayers then have 90 days from the mailing date to appeal the valuations. Mr. Welch said as of now, he cannot determine how much values will change, but it appears the total values will not change much due to reassessment. He thanked the Dorchester County ITS Department for their work in installing CAMA.

Chairman Chinnis said County Council voted to delay the 2014 appraisal to avoid having to run two computer systems simultaneously and to reduce the opportunity for errors.

COUNCIL MEMBER'S TIME - MR. WILLIAM R. HEARN, JR.

2. On the motion of Councilman Hearn, seconded by Councilwoman Duncan, Council voted unanimously to give 1st Reading (By Title Only) to an Ordinance amending Dorchester County Ordinance 04-13, Article XIII. Site Development Standards, Section 13.1.3 Light and request that staff investigate the current requirements and give a recommendation. This would include a referral of this subject to the Planning Commission for its recommendation based upon staff's investigation.

Councilman Hearn said this issue came to him from a constituent involved in the project to build a Wal-Mart Neighborhood Market on Dorchester Road. Current standards of development prohibit Wal-Mart from using lighting poles in excess of 15 feet. He said their specific concern and request involves the need for six light poles, 30-feet high, in the front of the store and three light poles, 30-feet high, around the loading dock.

Councilman Hearn said he wants to make sure the ordinances going forward are fair and business friendly for retail, commercial and industrial projects. Councilman Hearn said Mr. Tex Small of AVTEX Commercial Properties was in the audience and available to answer questions.

COUNTY ADMINISTRATOR'S TIME - MR. JASON WARD

GENERAL OBLIGATION BONDS

3. On the motion of Councilman Davis, seconded by Councilman Bailey, Council voted unanimously to approve 1st Reading of an Ordinance (By Title Only) to provide for the issuance and sale of not exceeding four million five hundred thousand dollars (\$4,500,000) Dorchester County, South Carolina, General Obligation Bonds, Series 2015, to provide additional funds for the construction of the detention center; to prescribe the purposes for which the proceeds shall be expended; to provide for the payment thereof; and other matters relating thereto.

During discussion, Councilman Hargett said he would vote for 1st Reading, but asked for more detail going forward. Councilman Davis said this is not one of his favorite things, but he knows we have to have a detention center. Chairman Chinnis said costs have outstripped what Council had hoped.

EMPLOYEE RECOGNITION PROGRAM

Chairman Chinnis thanked Mrs. Turner and Mr. Powell for their work on this revised program. Mr. Powell said there also was input from a committee of employees from across the organization. He thanked them for their work on this program.

Mr. Ward said this is related to property at the courthouse site in St. George, a portion of which has been designated for a park. Councilwoman Duncan asked if there were any grand oaks or grand pines on the property. Mr. Ward said Sabine and Waters, a natural resource management company, will ensure that we will have something aesthetically pleasing with the ultimate purpose being to preserve the site. He said this is a multi-step process, and Council will be involved in the ultimate conception and final design.

Chairman Chinnis called to order the meeting of the Dorchester County Council. He invited all to stand for the invocation, which was given by Vice Chairman Bailey and followed by the Pledge of Allegiance.

CHAIRMAN'S TIME

REQUESTS TO ADDRESS COUNCIL:

Ms. Phoenix Anderson, 105 Corsair Street, Summerville, said she moved here within the past year from California and was surprised by the lack of community services such as sidewalks, crosswalks, parks, playgrounds and collection of litter along roadsides. She called on Council to expand services.

- Chairman Chinnis noted that South Carolina residents do not have the tax burden that California residents have. He said Councilman Byars would likely appreciate the support of another volunteer on the Dorchester County Parks and Recreation Commission. Chairman Chinnis thanked Ms. Anderson for bringing her concerns to the attention of County Council.
- Mr. Rudd Smith, 201 South Hickory Street, Summerville, thanked County Council for the opportunity to serve on the Trident Technical College (TTC) Board of Directors and asked to be re-nominated for reappointment by the Governor, as his appointment expires in June. He updated Council with some statistics about the college, saying 55 percent of all graduating seniors in Dorchester County attend Trident Tech as first-time freshmen. He promoted TTC's apprenticeship program and aeronautical training center.
- Ms. Sandra Thorpe, 562 Hill Branch Road, Ridgeville, said she owns 3.42 acres on Beech Hill Road, the site of a planned daycare for 100 children. She said the daycare center is much needed in the community. She asked Council to waive the \$50,000 transportation impact fee.
- Mr. Anthony T. Conway, owner of 153 Prince Edward Drive, 130 Marie Drive and 206 Ponderosa Drive, Summerville, informed Council that since purchasing the corner properties he has cleaned them up, making improvements with all of the appropriate permits in place. He said these were previously problem properties with derelict mobile homes and alleged illegal drug activity. He has since evicted the tenants, removed the pre-1970s mobile homes and replaced them with 1996 mobile homes. He stated concerns about coming into Dorchester County to fix up properties and being met with grief from residents regarding the lot qualifying for grandfather clauses related to mobile homes and septic tanks.
- Ms. Laura Burr, 11095 Dorchester Road, Summerville, stated concerns about speeding on Dorchester Road and incomplete work on the ditches.
- Mr. John Allen, 11093 Dorchester Road, Summerville, asked for reflectors to be posted, warning drivers of the deep ditch on Dorchester Road. He asked about the paving schedule for Swan Drive and Pelican. He stated concerns about keeping the grass trimmed this summer in the newly constructed, deeper ditches. He requested patrolling by the Sheriff's Department in Teal on the Ashley to deter crime. He stated concerns about the dangerous location of the school bus stop. He thanked Council for support in getting the speed limit reduced from 30 to 25 miles per hour.
- Ms. Peggy Bangle, 114 Ravenwood, Summerville, discussed the Local Government Fund (LGF). This refers to local tax dollars collected by the counties and sent to the state with a statutory requirement that 4.5 percent of the state's general fund of the previous fiscal year be returned to the counties to pay for state-mandated services, such as court systems, jails, and election offices. She also discussed the fuel tax.

ADOPTION OF MINUTES

ADOPTION OF PROCLAMATION #15-02

2. On the motion of Councilman Bailey, seconded by Councilman Davis, Council voted unanimously to adopt Proclamation #15-02, Proclaiming Dorchester County Council's Support of the Edisto Natchez-Kusso Indian Tribe in Their Efforts to Obtain Federal Recognition.

CORRESPONDENCE: Mr. Ward reported that correspondence was forwarded to Council upon receipt.

GUEST: MR. THOMAS FEAGIN, PONDEROSA ROAD AND MARIE DRIVE

Mr. Feagin, 113 Ponderosa Road, Summerville, stated safety and health concerns regarding property at the corner of Ponderosa Road and Marie Drive. Mr. Feagin said he has respect for all the work that the new property owner has put into the corner lot at Ponderosa Road and Marie Drive, but said there is still more work to be done. Mr. Feagin said he is seeking action from the South Carolina Department of Health and Environmental Control (DHEC) regarding the close proximity of septic tanks in muddy soil, but said he has been unsuccessful to date in making contact with the proper officials. He said the property is best suited for a single-family residence, not a trailer park.

He questioned the close proximity of official residences. He stated concerns about potential new residents of the property reintroducing gunfire and illegal drugs into the neighborhood. He asked for help from Council in addressing this situation. The property owner, Mr. Conway, spoke during Requests to Address Council at the beginning of the meeting.

Chairman Chinnis stated there was a memo from staff and asked Council if there were any questions or observations.

Councilman Bailey said he made a site visit and met Mr. Conway. He said he also spoke with County staff and DHEC. Councilman Bailey said the problem is the grandfather clause, regarding the existing septic tanks. Whether we like it or not, the grandfather clause is there, said Councilman Bailey. The only thing I can recommend now is to monitor the property and when the septic tank lines surface, address it with DHEC, he said.

Councilman Hearn asked, is the County actively involved in any investigation, or are we waiting to hear back from DHEC, or have we heard back from DHEC? Where does the County stand, if at all, on this?

Mr. Alec Brebner, Dorchester County Planning and Zoning Manager, said DHEC has outsourced this to the private sector. He said the County has documentation that a DHEC-certified inspector has signed off on two septic tanks for that location to provide adequate sanitation for two homes. Another home will be tied into a sewer line. Mr. Conway has paid the impact fees to the sewer department; therefore, a set-up permit was issued, said Mr. Brebner. As he described, Mr. Conway does have the necessary permits. There are still inspections to conduct, said Mr. Brebner.

Councilman Hearn asked if the County would grant a CO, certificate of occupancy. Mr. Brebner said there are not COs granted to mobile homes, but there are inspections. County officials will verify that it is tied in before the County Building Department will indicate to the power company that it is safe to turn on power, he said.

Chairman Chinnis said he has to trust Mr. Conway at his word that he is trying to make something better that was a bad situation. He said he is not going to assume automatically that bad people are going to move in.

GUEST: MR. MATT HINES, PROJECT MANAGER, DENNIS CORPORATION, UPDATE ON S.C. HIGHWAY 165 (DELEMAR HIGHWAY) WIDENING

Mr. Hines reported that the budget has been updated with the total construction cost estimate, including contingency, being \$12.2 million. He said most of the increase is due to increased traffic control items, including a barricade wall during construction, which will require the construction of some temporary pavement in order to place it there. He said eight parcels are being acquired as part of this project with six in a level of agreement and two slated for condemnation. Mr. Hines gave an update on permitting, and then asked if there were any questions.

Councilman Hargett asked if the hiker/biker trail is still in the design from the high school to Carolinian Drive. Mr. Hines confirmed that it is still in the project, and it will be an eight-foot-wide sidewalk.

Councilman Byars said he is very frustrated with the timeline and the continued delays on a road that is a major safety issue. This is vexing to the point of insanity, he said.

There was some discussion among Council members and Mr. Hines.
