# MINUTES DORCHESTER COUNTY COUNCIL KENNETH F. WAGGONER SERVICES CENTER COUNCIL CHAMBERS, ST. GEORGE APRIL 6, 2015 7:00 P.M.

Chairman Chinnis called to order the meeting of the Dorchester County Council. He invited all to stand for the invocation, which was given by Councilman Davis and followed by the Pledge of Allegiance.

### **CHAIRMAN'S TIME**

### REQUESTS TO ADDRESS COUNCIL:

 Mr. Larry Beaudrot, 118 Bassett Lane, St. George, asked Council for support on Glover Drive in getting the ditches cleaned and the road paved.

- Mr. Albert Burden, 140 Alfred Avenue, Harleyville, asked for Alfred Avenue to be graded and repaired after heavy rains. He said it once was County maintained. He asked for County maintenance to resume.
- Mr. General Britt, 637 1<sup>st</sup> Texas Road, St. George, asked for County maintenance of Woodbridge Road.
   Councilman Davis asked for all those present from Woodbridge Road to stand. About a dozen people stood.
- Mr. Alfred Singletary, 130 Alfred Avenue, Harleyville, said Alfred Avenue was fixed about a year ago
  after residents signed a petition. He said the road was beautiful, until it rained. He asked for County
  maintenance of the road.
- Ms. Sandra Thorpe, 562 Hill Branch Road, Ridgeville, asked for Council to work with her on the \$50,000 transportation impact fee for her proposed daycare on Beech Hill Road. She said the impact fee is hurting small businesses.
- Mr. Howard Bridgman, 142 Gadsden Street, Summerville, said the Ashley River is considered one of the three most historically significant rivers in the southeast, along with the Potomac and the James. He said there are great opportunities for ecotourism along the river. He said the Ashley Scenic River Management Plan identified overuse by power boats as a potential problem for the upper Ashley River. He stated concerns that more access will lead to more use, and more use will threaten the river with increased noise, litter, vandalism, bank erosion and reduced safety and security. Power boats can access the river three miles downstream at Jessen Landing. The Advisory Council recommends the following: (1) No additional power boat facilities be constructed on the upper Ashley River and use of power boats there not be encouraged, (2) Impact studies should be conducted before new facilities are sited or designed, (3) River education efforts should target recreational users to inform them of the value of the river and the potential for negative effects on this irreplaceable resource, said Mr. Bridgman.
- Mr. George Neil, 301 Partridge Circle, Summerville, said he is a 39-year resident of Dorchester County with strong feelings about the value of the river to our community. He asked Council to remember that loans and grants with strings attached are not worth the money, no matter the blue-sky benefits. He said the proposed boat ramp at Bacons Bridge is one of the shallowest points on the environmentally sensitive Ashley River. He said weekend beer blasts are more likely to occur less than 500 feet from a residential neighborhood with lots of young children than the appreciation of nature and sensible recreation.
- Mr. George McDaniel, 102 Rutherford Street, Summerville, distributed to Council a conceptual drawing from the Scenic River Management Plan for the Ashley River at Bacons Bridge, which he said was developed in the 1990s. Mr. McDaniel said much of what is being proposed by Dorchester County staff is in keeping with this plan. The concern is for the proposed boat ramp to accommodate larger boats and jet skis. He said this portion of the river is more suited for canoes, kayaks or jon boats. He asked Council to defer approval of the boat ramp as proposed and look at some alternatives. Mr. McDaniel is the Executive Director at Drayton Hall.
- Mr. Jack Keeter, 311 Ashburne Court (Archdale), North Charleston, of the Ashley Scenic River Advisory Council, stated the groups' opposition to a motorized ramp that can handle big boats, fast boats and jet skis.
- Ms. Lisa Turansky, 328 East Bay Street, Charleston, spoke on behalf of the Coastal Conservation League, representing more than 4,000 members. She said the Ashley River Historic District is a success story that is worth protecting. She said the effects of motor boat ramps need to be studied more closely before moving forward. She offered assistance in coming up with alternative, creative solutions.
- Ms. Peggy Bangle, 114 Ravenwood Court, Summerville, asked for funding support from Berkeley County for Children in Crisis. She asked that the County Transportation Committee respond properly and timely to state requests. She also discussed the Local Government Fund (LGF). This refers to local tax dollars collected by the counties and sent to the state with a statutory requirement that 4.5 percent of the state's general fund of the previous fiscal year be returned to the counties to pay for state-mandated services, such as court systems, jails, and election offices.

Councilman Davis said he received a call from a resident of Pidgeon Bay Road, which falls in his Council District and that of Councilman Hearn. The constituent reported that dirt from approximately four feet on each side of the road had been removed for the purpose of fixing other roads, thereby damaging the lawns of residents. Councilman Hearn said he made a site visit, and the damage to residents' property by the South Carolina Department of Transportation (SCDOT) is as described. Mr. Ward said the Dorchester County Public Works Department has spoken with Mr. David Pilch, the resident SCDOT maintenance engineer, who is scheduled to meet with residents of Pidgeon Bay Road.

County Council recognized Mr. Charlie Kaufman, E911 GIS Analyst, who recently completed more than 200 hours of training in emergency management and general management to obtain the South Carolina Certified Emergency Manager designation.

The Chairman presented the Proclamation to Ms. Kay Phillips, Executive Director of Children in Crisis, and thanked her for her work and that of the center. Ms. Phillips thanked the citizens of Dorchester County who support the center through taxes, helping more than 1,000 children per year. She said it is heartwarming to live in a county that cares enough about children and their quality of life to support Children in Crisis so they may grow up to be productive citizens.

Chairman Chinnis struck the gavel, opening the Public Hearing. He invited the public to come forward to speak on this issue. Ms. Bangle spoke during the public hearing. In the absence of any additional requests from the public to speak, Chairman Chinnis struck the gavel again, closing the Public Hearing.

### COUNCIL MEMBER'S TIME - MR. WILLIAM R. HEARN, JR.

Councilman Hearn asked the Chairman to open a public hearing so County Council may receive public comments regarding a change in Ordinance 04-14 related to lighting standards.

Chairman Chinnis struck the gavel, opening the Public Hearing. He invited the public to come forward to speak on this issue. He recognized Mr. Brebner to describe the issue. There was some discussion among Council members and Mr. Brebner regarding 25 feet lighting poles versus 30 feet lighting poles. In the absence of any requests from the public to speak, Chairman Chinnis struck the gavel again, closing the Public Hearing.

5. On the motion of Councilman Hargett, seconded by Councilman Davis, Council voted unanimously give 2<sup>nd</sup> Reading of an Ordinance To Amend the Dorchester County Zoning and Land Development Standards, Ordinance 04-13, As Previously Amended, to Revise Article XIII. # GUEST: MR. ERIC DAVIS, DORCHESTER COUNTY PARKS AND RECREATION DIRECTOR

Mr. Davis presented recommendations from the Dorchester County Parks and Recreation Commission to improve access to the Ashley River in partnership with American Rivers. This partnership is an effort to develop an Ashley River Blue Trail, a formal set of river access points and points of interest marketed and utilized for many forms of water recreation and ecotourism. It would stretch from Schultz Lake above Highway 17A to Charleston Harbor. Currently, Jessen Landing is the only public access location to the Ashley River in Dorchester County.

The proposals from the Dorchester County Parks and Recreation Commission include a boat ramp at the Bacons Bridge location and a canoe and kayak carry-down site at the Swan Drive location. Mr. Davis said a primary benefit to installing a small boat ramp at the Bacons Bridge location is that it permits local Water Recreation funding via the South Carolina Department of Natural Resources (DNR) to leverage federal funding for water access at a rate of 1:4. The federal program that enables this leveraging is the Sportfish Restoration Fund, which requires access for motorized boats. Leveraging these funds is important because the cost to construct a paved access road, parking lot, restroom facility and associated infrastructure would likely exceed Dorchester County's Water Recreation account balance of \$210,762.

Mr. Davis explained that the Water Recreation funding is through a program managed by DNR, which receives funds from the gasoline tax and allocates them to counties based on the number of registered boats in their jurisdiction. The fund accumulates at a rate of about \$30,000 per year and is shared with the other municipalities in Dorchester County.

Regarding concerns stated by stakeholders during Requests to Address Council, Mr. Davis said County staff have met with DNR staff and discussed horsepower limits and no-wake zones as potential remedies. According to DNR, these are not viable tools, said Mr. Davis. He said it is the opinion of DNR that the natural characteristics of the river along this section (minimal water at low tide, narrow river channel, downed and overhanging trees, etc.), design of the access site, lack of a dock for loading/unloading passengers, and ample warning signage will regulate all but the smallest of motorized watercraft from launching at this site. Jessen Landing, a few miles away, is a much more enticing launch site for motorized watercraft.

Mr. Davis noted that he received a call from Mr. Jeff Thompson, wetland project manager for Charleston OCRM, who mentioned that the Special Area Management Plan (SAMP) does add an additional layer of regulation regarding the critical areas on this portion of the Ashley River. Mr. Davis said he assured him that nothing precludes DNR from submitting permitting requests for the recommended site development plans. They would then look to the SAMP and other OCRM regulations when considering the permit.

With Council approval, staff would work with the Dorchester County Legislative Delegation to request funding and technical assistance from DNR, which would handle all the permitting, engineering design and construction administration, adding approximately \$40,000 in value per site.

Mr. Davis answered questions from Council. Several Council members stated concerns about the potential for jet skis and large motorized boats on the upper Ashley River. Some Council members also noted that it would be beneficial to move forward to see what exactly DNR proposes.

6. On the motion of Councilman Byars, seconded by Councilman Davis, Council voted six in favor and one opposed to approve proceeding with development of an Ashley River waterway access canoe and kayak "carry down" site at the Swan Drive site and proceeding with development of an Ashley River waterway access site that includes a boat ramp at the Bacons Bridge site. Mr. Hargett cast the opposing vote.

During discussion, Chairman Chinnis said, I reserve the right to come back and look at this again because I have some of the same concerns.

Councilman Byars was not feeling well and left the meeting after the vote at approximately 8:30 p.m.

10. On the motion of Councilman Bailey, seconded by Councilwoman Duncan, Council voted six in favor, with one absent, to approve the reclassification and compensation adjustments in the Finance Department, Purchasing Department, Sheriff's Office and Probate Judge's Office as recommended by the Compensation Committee and outlined in the packet.

**EMPLOYEE BONUSES** 

11. On the motion of Councilwoman Duncan, seconded by Councilman Davis, Council voted six in favor, with one absent, to approve bonuses from personnel savings for the Water and Sewer leadership team that has taken on additional responsibility in the absence of a Director as outlined in the packet.

Chairman Chinnis said he appreciates the work of the Water and Sewer employees and the tasks they have taken on, so we can all turn on the faucets and flush the toilets.

BUDGET TRANSFERS FOR ARCGIS

12. On the motion of Councilman Davis, seconded by Councilwoman Duncan, Council voted six in favor, with one absent, to approve a transfer of \$33,646 from personnel line items in the Assessor's Office, a transfer of \$15,000 from operating in the Water and Sewer Department (Lake Marion savings) and a transfer of \$15,000 from salaries in the Stormwater Division. All three transfers will go to operating in the Assessor's Office to purchase and implement the new software.

LIGHT DUTY POLICY AMENDMENT

13. On the motion of Councilman Davis, seconded by Councilman Hearn, Council voted six in favor, with one absent, to delete the existing Section 108, Light Duty Policy, from the Personnel Policies and Procedures Manual and replace it with a new Light Duty and Restricted Duty Assignment Policy that was developed by Risk Management and reviewed by the County Attorney, clarifying how light duty assignments will be made and the responsibilities of those involved in the program.

NONPROFIT "PARK FRIENDS" GROUP

### EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM

Chairman Chinnis called on the County Administrator to describe the grant application. Mr. Ward said Dorchester County is applying for a \$24,526 grant to purchase 13 body-worn cameras for patrol deputies, as well as two charging docks and two 32-terabyte servers for data storage. No local match is required, he said.

Chairman Chinnis struck the gavel, opening the Public Hearing. He invited the public to come forward to speak on this issue. In the absence of any requests to speak, Chairman Chinnis struck the gavel again, closing the Public Hearing.

### SC COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

Chairman Chinnis struck the gavel, opening the Public Hearing. He called on Mr. Ward to describe the Dorchester County Needs Assessment Public Hearing format.

Mr. Ward said the purpose of the public hearing is to solicit input concerning Dorchester County's Community Development Block Grant Citizen Participation Plan and Community Needs Assessment. The Citizen Participation Plan is a guide developed by Dorchester County in conformance with S.C. Department of Commerce administrative requirements and U.S. Department of Housing and Urban Development regulations. Mr. Ward asked all present to sign the sign-in sheet, if they had not already, in order to have a record of attendance in securing funding.

The priorities of Dorchester County's 2014 Community Needs Assessment were as follows:

- 1. Economic Development activities that create employment opportunities and training, upgrade existing library facilities, community computer access, energy improvements, etc, particularly in St. George in order to offer better services to the residents of upper Dorchester County that are predominately low and moderate income.
- 2. Water and Sewer Service in low and moderate income areas. There are several specific areas of Dorchester County that are predominately low and moderate income and would benefit from the installation or upgrading of these services.
- 3. Housing Activities that provide a Safe/Decent Living Environment for low and moderate income families.

Mr. Ward asked if there were any questions or comments concerning the County's Citizen Participation Plan or Community Needs. Chairman Chinnis asked if there were any comments from the public. In the absence of any public comments, Chairman Chinnis struck the gavel, closing the Public Hearing.

### FY 2015-2016 COUNTY BUDGET

2. On the motion of Councilman Hearn, seconded by Councilman Byars, Council voted unanimously to amend the Dorchester County Budget Ordinance for Fiscal Year 2015-2016 as follows:

The General Fund shall include the following adjustments:

Decrease the revenue line item from \$286,000 to \$0 to reflect that the county will no longer provide four SROs to Dorchester School District 2.

Decrease the revenue line item from \$71,500 to \$60,000 to reflect that the county will no longer provide a SRO Supervisor to Dorchester County Career & Technology Center.

Increase the revenue line item from \$71,500 to \$120,000 to reflect that the county will provide an additional SRO but will no longer provide a SRO Supervisor to Dorchester School District 4.

Increase Fines & Penalties revenue line item by \$920,000 to reflect that county will convert two former SROs to traffic unit deputy positions that patrol the interstate.

Decrease transfer revenue from the Fire Fund by \$16,602 due to overhead allocation adjustment.

Decrease the Personnel line items in Magistrate Department by \$156,304.

Increase the Personnel line items in the Sheriff's Office by \$140,709 to cover the costs.

Increase the Personnel line items in the Administrator's Office by \$18,434.

Increase the Personnel line items in the Attorney's Office by \$10,735.

Increase the Personnel line items in the Sheriff's Office by \$80,824 to add salary and benefits for 2 new dispatcher positions. Convert former SRO to deputy in warrants division.

Increase the Mobile & Cell Phones line item in the Sheriff's Office by \$11,520 to provide 32 patrol deputies with cell phones.

Increase the Direct Assistance line item for the Solicitor by \$95,000 to provide an Assistant Solicitor and an Investigator position.

Increase the Contingency line item in County Council by \$10,000.

Increase the Contingency line item in the Administrator's Office for part time contingency by \$20,000.

Increase the Workers Compensation line items across all departments by \$157,019 to cover the cost of an increase in the projected modifier for FY2016.

Increase the transfer line item for Veterans Affairs, Victims Advocate and E-911 Funds by \$3,280 to cover the cost of a 2.5% merit increase for eligible employees effective January 2016.

Increase the Personnel and Benefits line items across all departments by \$276,755 to cover the cost of a 2.5% merit increase for eligible employees effective January 2016.

The total expenditures for the General Fund shall increase from \$48,233,528 to \$48,904,528.

The Capital Fund shall include the following revisions:

Reduce the Vehicle line item in Facilities & Grounds Maintenance by \$7,000.

Reduce the Vehicle line item in the Administrator's Office by \$1,229.

Increase the Debt Service line item in Fiscal Agent Fees by \$8,229 to cover the cost of the jail lease for kitchen and security equipment.

The total expenditures for the Capital Fund shall remain at \$3,691,013.

In the Water and Sewer Fund shall include the following revisions:

Increase sewer fee revenue line item by \$45,595 to reflect the anticipated rate increase for FY16.

Increase the personnel and benefits line items by \$30,940 to cover the cost of a 2.5% merit increase for eligible employees effective January 2016.

Increase the workers compensation line item by \$14,655 to cover the increase in workers compensation premiums due to an increase in the modifier for FY2016.

The total expenditures for the Water and Sewer Fund shall increase from \$30,610,236 to \$30,655,831.

In the Stormwater Fund, the personnel and benefits line items shall increase by \$6,920 to cover the cost of a 2.5% merit increase for eligible employees effective January 2016. Also, the workers compensation line item shall increase by \$6,280 to cover the cost of an increase in the projected modifier for FY2016 with a corresponding decrease in the Expansion of Systems line item.

In the Solid Waste Fund, the personnel and benefits line items shall increase by \$13,400 to cover the cost of a 2.5% merit increase for eligible employees effective January 2016. Also, the workers compensation line item shall increase by \$10,468 to cover the cost of an increase in the projected modifier for FY2016 with a corresponding decrease in the Recycling line item.

In the Recreation Fund, the personnel and benefits line items shall increase by \$325 to cover the cost of a 2.5% merit increase for eligible employees effective January 2016 with a corresponding decrease in the Fuel line item.

In the Fire Fund, the personnel and benefits line items shall increase by \$11,844 to cover the cost of a 2.5% merit increase for eligible employees effective January 2016. Also, the workers compensation line item shall increase by \$4,758 to cover the cost of an increase in the projected modifier for FY2016 with a corresponding decrease in the Transfer to the General Fund line item.

And, increase the following revenues based upon the June 1, 2015 revenue estimates:
