ORDINANCE NUMBER 22-22

COUNTY OF DORCHESTER

**AN ORDINANCE TO AMEND DORCHESTER COUNTY ORDINANCE NO. 22-16 TO LEVY AND IMPOSE A ONE PERCENT SALES AND USE TAX, SUBJECT TO A REFERENDUM, WITH RESPECT TO CERTAIN PROVISIONS SET FORTH IN SECTION 2.4 OF SAID ORDINANCE**

**BE IT ENACTED BY THE COUNTY COUNCIL OF DORCHESTER COUNTY, SOUTH CAROLINA, IN MEETING DULY ASSEMBLED:**

**WHEREAS**, the County Council of Dorchester County, South Carolina (the "County Council"), the governing body of Dorchester County, South Carolina (the "County"), and the body to which is delegated the administrative duties of the County, gave third and final reading to Ordinance No. 22-16 on July 25, 2022 (the "Ordinance No. 22-16"), to levy and impose a one percent sales and use tax subject to a referendum; and

**WHEREAS**, on September 19, 2022, the County Council conducted a public hearing on said Ordinance No. 22-16 as required by state law; and

**WHEREAS**, as a result of public comment and public input, the County Council is desirous of amending certain provisions of Section 2.4 of Ordinance No. 22-16.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COUNCIL, DULY ASSEMBLED, THAT THE FOLLOWING AMENDMENTS ARE MADE TO ORDINANCE NO. 22-16:**

Section 1. With respect to Section 2.4(i), the words "and Ladson Road Extension" are deleted from Projects of regional significance.

Section 2. With respect to Section 2.4(i), the following words are added to the end of Projects of local significance: "; and facilities designed for the purpose of alleviating the use of automobiles and automobile traffic and encouraging commuting by other means such as commuter bicycle and pedestrian paths including, but not limited to, projects such as the Sawmill Branch Trail".

Section 3. With respect to Section 2.4(ii), the words "to provide trails and outdoor recreation" are deleted and the words "lands for open space by purchase or easement "are added.


Section 4. With respect to Section 2.4(i), the words "Glenn McConnell Parkway" are deleted from Projects of regional significance and the words "transportation facilities in the Ashley River corridor" are added to the Projects of regional significance.

Except as amended hereby, Ordinance No. 22-16 shall remain in full force and effect.


