De-titling a Mobile Home

- A Building Safety Permit must be completed by Building Services. This permit costs \$60.
- Building Services will go out and inspect the Mobile Home. Inspector may need to enter home to perform inspection. The following information will be obtained during the inspection: Make and model of home; Serial number; Size of home; Blocking and Tie-downs; Type of under-pinning; Tongue attached or removed; Any attachments to home (deck, porch, room, etc).
- After the inspection is approved, the inspection report with all required information
 is given to the owner for them to take to the Register of Deeds Office (ROD) to have
 recorded WITH the Manufactured Home Affidavit for Retirement of Title Certificate and a few
 other documents. (Owners can obtain a blank form from the ROD office if needed). There is
 a fee of \$25 to have these documents recorded with ROD.
 - **See additional information and instructions from the ROD office on page 5 **
- The owner must mail the recorded documents to the DMV in Blythewood for approval. There is a charge of \$50 but please call or check with the DMV to verify the charge.
- After the Affidavit is recorded, the Assessor gets a copy from the ROD. This is when the Assessor's Office is notified that the owner has started the process.
- At this point, the MH Retirement Affidavit is only recorded. The owner still must get
 confirmation from the DMV that the MH has been detitled. The owner should send a copy of
 the confirmation letter to the Assessor's Office for the MH to be combined for taxation the
 following tax year. The Assessor's Office will combine the MH with the land parcel for the
 future tax year and delete the individual Mobile Home record so that it won't be double taxed.

^{**}This process does not start in the Assessor's Office. Please confirm each of these processes with the correct office to ensure the process or fee for services have not changed.

REQUIREMENTS FOR DETITLING A MOBILE HOME

- Stamped Manufactured Home Affidavit or the Retirement of Title Certificate recorded with the Register of Deeds Office with County's approved inspection
- Home's SC title
- Lien release (if applicable)

If the lien is not released on the title, an SC-licensed attorney may record a Satisfaction of Lien Affidavit in the county the home is located. If there's a lien on the home when you plan to de-title it, you must file an affidavit with the county's clerk of court.

- Current paid property tax receipt
- \$50 de-titling fee
- CONFIRMATION LETTER <u>MUST BE SENT TO COUNTY ASSESSOR'S OFFICE</u> FOR THE MOBILE HOME AND LAND TO BE COMBINED FOR TAX PURPOSES.

Title: De-titling Manufactured Homes

- 1. The owner must submit the Manufactured Home Affidavit for the Retirement of Title Certificate from the Register of Deeds or the Clerk of Court in the County where the mobile home is located. This must be stamped with the date and time stamp received at this County.
- 2. The Information on the Manufactured Home Affidavit for the Retirement of Certificate of Title must match the information on the accompanying title. (Year, make, vehicle identification and owner name.)
- 3. The title information including the title number must match the information shown on the Department of Motor Vehicle files.
- 4. A Lien Release must be provided for each lien recorded on the title by having the lien release signed by an authorized agent of the lien holder.
- 5. If the lien is not released on the title, any attorney licensed to practice law in the state may record a Satisfaction Affidavit in the County of which the mobile home is located. They have to submit proof of payment to the county. This Affidavit is sufficient to release the lien with DMV.
- 6. If the manufactured home still has a lien at the time the title is retired, you must file a manufactured home Lien Affidavit with the Register of Deed or Clerk of Court in the county where the manufactured home is located. It will then become a lien against the real property.
- 7. The lien or liens shown on the title either has to be satisfied or a copy of this lien affidavit must be recorded with the documentation to the DMV.
- 8. A tax receipt must be provided for the manufactured home indicating property taxes have been paid for the current year. (We will accept a statement on the County Treasurer's Letterhead that no taxes are currently owed on the home.)
- 9. The fee for retiring a manufactured home title is \$50.00.
- 10. The Department of Motor Vehicle must maintain a record of each manufactured home title certificate that is retired.
- 11. The Department must provide written confirmation to the homeowner that the certificate of title has been retired.
- 12. When you have received a confirmation letter of De-Titling from the DMV, forward a copy to your County Assessor's Office to be taxed as Real Estate for the **future** tax year. The address for Dorchester County is below.

De-titling Your Mobile or Manufactured Home

You may **only** de-title your mobile home through the mail. You'll mail all documents listed below to the following address:

If you're interested in de-titling your home, you must submit all of the following:

- Stamped Manufactured Home Affidavit or the Retirement of Title Certificate
 You receive this document from your home's county register of deeds or the clerk of court.
- · Home's SC title
- Lien release (if applicable)
 If the lien is not released on the title, an SC-licensed attorney may record a Satisfaction of Lien Affidavit in the county the home is located. If there's a lien on the home when you plan to de-title it, you must file an affidavit with the county's clerk of court.
- Current paid property tax receipt
 If you do not owe property taxes, the SCDMV accepts a letter from the county treasurer that says you do not owe taxes.
- \$50 de-titling fee

The SCMDV will provide written confirmation that the home has been de-titled.

**Additional information from the Register of Deeds Office **

Pursuant to SC Code of Laws 56-19-510, a mobile home may be detitled if certain steps are taken.

The Dorchester County Register of Deeds office requires the following documents be recorded as a package to meet the minimum requirements.

- 1. Affidavit for Retirement of Title This form is available online at South Carolina Legislature Online (scstatehouse.gov) under SC Code of Laws, Title 56 which is copied below.
 - This form must be Witnessed and Notarized prior to recording.

No staff member of the ROD office can or will witness or notarize a document which is to be recorded in this office. Th ROD office has blank forms and can provide one for you, but it must be filled out by the applicant prior to recording. The ROD staff CANNOT fill out the form. The ROD staff CANNOT act as a witness or notary.

- 2. Proof of payment of all taxes due. This can be obtained from the county Treasurer and Delinquent Tax offices. A 'Sign Off' sheet is included with this information to make it more convenient for a citizen show taxes have been paid.
- 3. A copy of the title/deed to the real property to which the mobile home will become attached to. This can be obtained at the Register of Deeds office prior to or simultaneous with filing. There is a .50 charge per page for copies or the documents can be downloaded and printed from your personal computer at home for no charge.
- 4. A Building Safety Permit from the Building Services Department current with the requested filing of the Affidavit of Retirement.
- 5. Filing Fee of \$25.00 as prescribed by SC Code of Laws 8-21-310 (2) (k).

SECTION 56-19-510. Owner affixing manufactured home to real property; Manufactured Home Affidavit for the Retirement of Title Certificate; recording and form of affidavit.

- (A) An owner of a manufactured home may affix the home to real property by:
- (1) installing the home in accordance with the required installation standards and removing the wheels, axles, and towing hitch; and
- (2) filing with the register of deeds or clerk of court, as appropriate, for the county in which the manufactured home is located the Manufactured Home Affidavit for the Retirement of Title Certificate in the form prescribed in this article together with proof of ownership as evidenced by a copy of the most recent deed of record or other instrument vesting title, and paying the filing fee required for affidavits by Section 8-21-310.
- (B) The register of deeds or clerk of court must record the affidavit as if it were a deed to real property with the homeowner being identified as grantor and give notification to the county assessor.
- (C) Upon the filing of the affidavit, the manufactured home is to be treated for all purposes except condemnation as real property and title to the manufactured home is thereby vested in the lawful owner of the real property to which it is affixed. A warning notice to those filing the affidavit must be included in the affidavit.
- (D) The Manufactured Home Affidavit for the Retirement of Title Certificate must be in the following form:
