

1. **Call to Order of board meeting-** *The meeting was called to order at 10:13 a.m. by acting chairperson, Mr. Bryan Black.*
2. **Approval of Agenda** – *Ms. Bowman made a motion, seconded by Mr. Profit, all in favor, to approve the meeting agenda.*
3. **Review of previous minutes** – *Mr. Debney made a motion, seconded by Ms. Bowman, all in favor, to approve the January meeting minutes.*

5. **Director's Report**
  - a. *SC Senate/SC House Redistricting* – *Ms. Scott mentioned the new senate changes are complete and voters have been moved into the new senate districts. The house district changes are complete except for precincts with split house districts. Ms. Scott has asked Mr. David Garber to provide the streets and the appropriate districts for those split precincts.*
  - b. *SC House District 109/ Town of Summerville Special Elections*– *The special elections for SC House District 109 and Town of Summerville District 3 will be April 2<sup>nd</sup>. Early voting will be March 18<sup>th</sup> – March 29<sup>th</sup>. Christ Lutheran Church and Rollins Edwards Community Center will be the early voting locations.*
  - c. *Republican Presidential Preference Primary*– *The Republican PPP election will be on February 24<sup>th</sup>. Early voting will begin February 12<sup>th</sup> – 22<sup>nd</sup> excluding Sunday and holidays.*
  - d. *Ethics Forms*- *The board was reminded that the deadline to submit their ethics forms is March 30<sup>th</sup>.*
  - e. *Candidate Filing* – *Candidate filing will open Noon, March 16<sup>th</sup> and closes Noon, April 1<sup>st</sup>. Forms and filing fee information can be found on scvotes.gov.*

6. *Unfinished Business – There was no unfinished business.*
7. *New Business - Mr. Profit recommended to present Ms. Peggy Bangle with her plaque at the next County Council meeting in Summerville.*
8. *Adjournment – Ms. Bowman made a motion to adjourn, seconded by Ms. Ewers, all in favor. The meeting adjourned at 10:34 a.m.*
