ORDINANCE NUMBER 11-04

AN ORDINANCE TO AMEND DORCHESTER COUNTY ORDINANCE 02-03 WHICH  
CREATED THE DORCHESTER COUNTY CONSERVATION COMMISSION

WHEREAS, Dorchester County Council adopted Ordinance 02-03 creating a  
Dorchester County Conservation Commission on February 4, 2002; and

WHEREAS, Dorchester County Council desires to amend Ordinance 02-03 in  
certain particulars as more fully set forth below.

NOW, THEREFORE, be it ordained by Dorchester County Council, duly  
assembled, that Ordinance Number 02-03 is hereby amended as follows:

1. Section II, A. is deleted in its entirety and the following is substituted  
in lieu thereof as a new Section II, A.: "The Dorchester County Conservation  
Commission shall consist of seven members appointed by Dorchester County  
Council. The term of each member shall be four years from date of appointment.  
Members of the Dorchester County Conservation Commission shall be active  
members of conservation/preservation organizations such as the Audubon Society,  
Friends of the Edisto, Ashley Scenic River Advisory Council, Upper Dorchester  
County Historic Society, or like organizations. Persons seeking to be appointed to  
the Dorchester County Conservation Commission shall make application for  
membership on a form prescribed by the Dorchester County Administrator, said  
applications to be submitted to Dorchester County Council for appointment to the  
Commission.

2. Section VI, C. is deleted in its entirety and the following is  
substituted in lieu thereof as a new Section VI, C. "To make recommendations to  
Dorchester County Council for the expenditure of funds received by virtue of the  
Referendum conducted on November 2, 2010, authorizing the issuance of \$5  
Million General Obligation Bonds for the purposes set forth in the Referendum,  
save and except recommendations for parks and/or recreation."

3. Section VII, A. shall be amended to add after the words "The  
Commission" the following phrase "in conjunction with and with the assistance of  
the staff of Dorchester County".

4. Section VII E.3 is deleted in its entirety.

Except as specifically amended hereby, Dorchester County Ordinance 02-03 shall remain in full force and effect.


