ORDINANCE NUMBER 13-07

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES, DORCHESTER COUNTY, SOUTH CAROLINA, TO DELETE THE TEXT OF ARTICLE IV, SEC.2-412(a) AND TO SUBSTITUTE NEW TEXT IN LIEU THEREOF SO AS TO CHANGE THE COMPOSITION AND MEMBERSHIP OF THE COUNTY PARKS AND RECREATION COMMISSION AND TO DELETE THE TEXT OF ARTICLE IV, SEC. 2-415 SO AS TO DELETE THE *EX OFFICIO* MEMBERSHIP IN THE SAID COMMISSION BUT TO RESERVE THE SECTION NUMBER.

WHEREAS, Dorchester County Council desires to amend the Code of Ordinances, Dorchester County, South Carolina with respect to the composition and membership of the county parks and recreation commission and to delete the provisions providing for *ex officio* members.

NOW, THEREFORE, be it ordained by the Dorchester County Council, duly assembled, as follows:


The text of Article IV, Sec. 2-412(a) is deleted in its entirety and the following text is inserted in lieu thereof:

“The County Parks and Recreation Commission shall consist of eight (8) members appointed by County Council. With respect to seven (7) of the eight (8) members, each member of County Council shall have the right to place into nomination one member who shall be a resident of Dorchester County to be appointed by a majority vote of County Council. Each of these members shall serve a term that shall expire at the same time as the Council member who nominates them, unless sooner removed by majority vote of County Council. The eighth (8th) member of the Commission shall be a member of County Council who shall be appointed by a majority vote of County Council and whose term shall expire at the same time as his term of office as a member of County Council unless sooner removed by a majority vote of County Council. Any person seeking to be appointed to the Commission, save and except the County Council member, shall make application for membership on a form prescribed by the County Administrator, which application shall be submitted to County Council for appointment.”

The text of Article IV, Sec. 2-415 is deleted in its entirety, but the section number is reserved for future use.

Except as specifically amended hereby, the Code of Ordinances, Dorchester County, South Carolina shall remain in full force and effect.
