### ORDINANCE TO AMEND THE CAPITAL IMPROVEMENTS PLAN FOR ROADWAYS IN UNINCORPORATED DORCHESTER COUNTY PROGRAMMING PROJECT #R-21 – US-17A FROM FLOOD HEIRS ROAD TO SC-642 – TO BEGIN FY'14 WHILE POSTPONING PROJECT #R-01 TO FUTURE YEARS

WHEREAS, Dorchester County Council has adopted by Ordinance #10-23 a Capital Improvements Plan, which consists of the Capital Improvements Plan for Roadways in Unincorporated Dorchester County, Final Report dated June 10, 2010, as revised and updated by Final Report dated November 23, 2010, and the Transportation Impact Fee Study Report developed by Kimley-Horn & Associates, Inc., Final Report dated June 10, 2010, as revised and updated by Final Report dated November 22, 2010, the same being incorporated therein by reference and attached thereto as Exhibit "A", which collectively are the Capital Improvements Plan for Public Facilities as more specifically defined in Section 6-1-920(18)(d), Code of Laws of South Carolina (1976);

WHEREAS, Dorchester County Planning Commission has reviewed the Capital Improvements Plan as required under SCC §6-1-950(B) and recommended amendments as detailed in the attached documents, Capital Improvement Project Detail Sheet #R-1 and Capital Improvement Project Detail Sheet #R-21, on October 17, 2013; and

NOW THEREFORE, BE IT ORDAINED BY DORCHESTER COUNTY COUNCIL, DULY ASSEMBLED, that the Capital Improvements Plan for Roadways in Unincorporated Dorchester County is amended so as to schedule Project #R-21 – US-17A from Flood Heirs Road to SC-642 – to begin in FY'14 while postponing project #R-01 to future years, as more specifically detailed in the attached Capital Improvement Project Detail sheets.




