RESOLUTION NUMBER 14-13

COUNTY OF DORCHESTER

A RESOLUTION AMENDING RESOLUTION 14-02 AS AMENDED BY RESOLUTION 14-11 FOR THE HOME GARAGING OF COUNTY VEHICLES BY CERTAIN DESIGNATED COUNTY EMPLOYEES

WHEREAS, pursuant to Resolution 08-20 and Resolution 10-04, County Council provided for the home garaging of County vehicles by certain County employees; and

WHEREAS, by Resolution 14-02, County Council repealed Resolutions 08-20 and 10-04 and provided for the home garaging of certain assigned vehicles; and

WHEREAS, County Council amended Resolution 14-02 by Resolution 14-11 to add home garaging for any Animal Control Officer scheduled to be on call after normal business hours.

WHEREAS, County Council wishes to further amend Resolution 14-02, as amended by Resolution 14-11, to add home garaging for Fire Battalion Chiefs.


NOW THEREFORE, be it resolved by Dorchester County Council, duly assembled, that Resolution 14-02 as amended by Resolution 14-11, be further amended so that following such amendment home garaging shall be as follows:

The vehicles assigned to the following positions shall be exempt from the requirement that the vehicle be garaged at an appropriate County building, thus allowing the vehicles so assigned to be home garaged: County Administrator, Deputy County Administrator, Director of Emergency Management, EMS Command Staff, (Director, Deputy Director, Training Officer and Shift Supervisors), Director of Public Works, Deputy Director of Public Works, Coroner and Deputy Coroners, Economic Development Director, Water and Sewer Director, Water and Sewer Deputy Director of Operations and Maintenance, Senior Sewer Plant Manager, Water and Sewer Operations and Maintenance Superintendent, Water and Sewer Department employees who are scheduled to be on- call after normal business hours, any Animal Control Officer scheduled to be on call after normal business hours, County Wrecker Operator(s) scheduled to be on-call after normal business hours, Risk Manager, Sheriff and Sheriff's deputies, Fire Chief, Deputy Fire Chief, Fire Battalion Chiefs, Battalion Chief for Training, Family Court Process Server(s), Director of Planning and Zoning, Magistrate Court Constables as deemed appropriate by the Sheriff, and the County employee(s) responsible for mosquito abatement during the mosquito season. The designation of these county positions for which home garaging is allowed shall in no way prohibit the County Administrator from allowing the occasional home garaging of a County vehicle by a County employee under appropriate and justifiable circumstances.
